Replacement at Bogton should take place by Mid August . He will take forward the agreement by NHS to replace Randolph Lane equipment. 3c Accident on A96, Market Street Junction: E. Hayward reported that she had contacted Steven Davies of Transport Scotland to express serious concerns. He responded that accident statistics are reviewed on a regular rota and the limited funding available is targeted at the most needy. BEAR Scotland and Police Scotland review had identified one injury since 2005 and this did not justify improvements. Accidents which involve damage to vehicles are not always reported. The situation will continue to be reviewed on an annual basis and appropriate action will be taken. S. Noble asked how many accidents have to occur before action is taken. A MOTP reported that the lines at the junction have been repainted. Cllr Alexander mentioned the survey cameras which are in place near the junction. These have been installed by Transport Police to monitor the level crossing. 3d Clovenside Road and other traffic issues: Kevin Price has responded that no action is able to be taken about the wall. North Road: The site manager has been contacted and there is no perceived problem. E. Hayward said that vehicles continue to reverse on the one way street. Redcraig: Monitoring equipment will be put in place as soon as it becomes available. St Catherine's Road: Cllr Alexander is hopeful that the completion of the next phase of houses will trigger the improvements. E. Hayward reported that there is road congestion near the Health Centre especially at school opening and closing times. C. Rodger feels that speed has been reduced by installation of the traffic lights. Presentation on Planning for Real: The first meeting of the Working Group was facilitated by Sylvia Jamieson. Names of those proposed to be part of group are: S. Noble, G. Murdoch, C. Rodgers, S. Hogg, L. Creswell, Sandra Maclennan, Representatives from TMC Planning and Sports Hub and 2 Forres residents (tbc). The event will be promoted as 'Forres 2020 Vision'. The model will be completed by the end of October; town roadshow at various venues by end December/ January; action plan to be completed by end January.
