I have read within the Council website your consultation in connection with the above, and note your request for further information.

This can be provided as follows:

- 1. There would be no impervious hardstandings within the proposed area and surface water would not discharge from the site to the SPA.
- 2. All proposed activities would remain outwith the SPA boundary at all times, including the storage of materials or access by vehicles
- 3. Full consideration will be given to the presence of giant hogweed. It is our understanding that there is not any hogweed within the proposed site, and any detected prior to ground works would be referred for specialist removal to ensure that there is no spread occurring.
- 4. All contractors will be advised of the environmental sensitivities and boundary of the SPA and a plan provided within Pre-Construction Information.

In summary, there should be no impacts on any of the interests of the protected areas. It is not proposed to site caravans on the proposed area.
