<u>Speeding through Dyke/Speed Limit</u> – This was previously looked into by DLCC but will be looked at again. SA wondered if DLCC could put up a home made sign. It was agreed that if the speed awareness sign was requested again it should be put at the start of the village. Action for the next meeting is to think what calming measures DLCC can put in place and then agree a plan of action. TMcL will write a letter to the primary school and see if they have any ideas too.

<u>Secretary</u> – TMcL is happy to stay on as secretary until a new one can be found. She will speak to a Broom of Moy resident who she thinks might be interested. New members need to be co-opted soon.

<u>Noticeboards</u> – Jane Martin had contacted Lorna Cresswell to say that the DLCC grant can be used to put up the noticeboard. TL will contact her to see if planning is required.
