Minutes of a meeting held on Monday 4th June 2018 at Keith Community Centre

1. **Members in attendance** Neil Kidd (Chair), Susan Hutcheon, Fiona Addison (from 7.25pm), Steve Hickin, Dave Carson and Catherine Sinclair

Welcome and Apologies: Neil welcomed everyone to the meeting. Apologies were received from Sandy Dickson (Vice Chair), Sandra Clark, Marguerite Cruickshank, and Cllr Shepherd

2. Approval of minutes from last meeting: The minutes were approved as accurate by Susan Hutcheon and seconded by Neil Kidd

3. Police Matters:

The Community Safety Report was read and discussed. From the last meeting, the bale of hay has been investigated and road patrols have been stepped up re speeding. There was also a discussion about antisocial behaviour in Keith and specific concerns that members of the public had raised were passed on. Again, the Police urge people to report concerns on 101. These are logged centrally and the intelligence is used to direct patrols and resources. Meanwhile, Police are aware of these crimes of disorder and are clearing them and inroads are being made. Enquiries into vandalism at St Rufus Park are ongoing and the possibility of placing a temporary CCTV camera will be looked into.
