The previous methods of communication which has been unchanged for several years only reaches limited members of our community through the Forres Gazette and noticeboards and the CC needs to ensure channels of communication are fit for purpose and we reach all members of our communities.

c) WW1 Plaque Update

The Chair explained of the delay of MC Planning on the plaque and that they were going to be charge £50 to find out if the likelihood of us being successful with the planning application and that a further £220 was required afterward.
