The Chairman welcomed members and the Berry Burn representatives to the meeting

1. BERRY BURN

Alison, Micheál and Peter gave a presentation about the new Berry Burn 2 project. The original windfarm consists of 29 turbines and this second section will have a further 10 turbines. Planning will be submitted early next year and there will be a series of exhibitions prior to this so that the public can feed into the planning process. Community funding of around £175,000 will be available. We were invited to discuss various options available and to approach them later with any further suggestions.

2. APOLOGIES

Apologies were received from Mr Scott Masson, Mr Colin Souter, Mr Peter Austin and Ms Jo Kirby.

3. MINUTES OF PREVIOUS MEETING

The Minutes were approved. Proposed Mr N McLeod, seconded Mr N Sutherland.

4. MATTERS ARISING

- a. Councillor attendance: It was made clear that we do not expect all councillors to attend our meetings. In the past we have had an attendee from the Heldon and Laich Ward and one from the neighbouring Fochabers-Lhanbryde Ward. Councillor Edwards has agreed to continue as the Heldon and Laich representative and it was agreed that we would invite a councillor from Fochabers-Lhanbryde to attend.
- b. Clash Gour: representatives have been invited to one of our meetings but have not so far attended.
- c. Dallas hydrants: these are tarred over and so far no action has been taken.

d. Community Council expenses: this had been raised at the JCC meeting but it is not clear how many CCs, if any, do claim expenses and if so, for what. Councillor Edwards will investigate.

5. CORRESPONDENCE RECEIVED

Most of the correspondence had been circulated.

- a. The JCC meeting will be held on Thursday 08 August
- b. The Energising Communities meeting is scheduled for 30 August in Forres Town Hall at 7.00 pm.
- c. Grass cutting equipment: the Council has indicated that there is no redundant equipment as it is still being used.
- d. Rural Transport Conference: this will take place on 09 October in Perth. Transport is a problem in our rural area and funds are available if anyone wishes to attend.
- **e.** Charleston Stable Roseisle: this is the property of the Forestry Commission and is being offered for sale to the community now it is no longer in use.
- f. Scottish Land Agency: a meeting is scheduled for 21 August at 7.00 pm in Forres Town Hall. Communities can bid for land that is unused or derelict.

6. FINANCE REPORT
