2	<p>Police Report</p> <p>PC Robson reported on activities within the Innes Community Council area over the past month.</p> <p>Concerns were raised over the following issues: quad bikes using Lossie Forest, parking in St Andrew's Road, Lhanbryde, speeding vehicles in Garmouth, Lhanbryde and Urquhart, a vehicle revving its engine for long periods in the car park, Station Road, Lhanbryde and also use of the same area as an authorised camping site by a motorhome. PC Robson took note of these concerns.</p> <p>She left the meeting.</p>	
3	<p>Moray Council Report</p> <p>Cllr Morrison advised that the Council's budget process for the next</p>	

	<p>financial year had started.</p> <p>The Scottish Government had agreed to fund the replacement of the bridge in Lossiemouth, which will then be managed by Lossiemouth Community Trust.</p> <p>She went on to say that the Councillors had received a report on the roll out and savings brought about by the installation of LED street lighting.</p> <p>An internal consultation on new management structures for the Council had been undertaken, and a report would be going to Full Council in October.</p>	
4	<p>Minutes of the Previous Meeting</p> <p>The minutes of the meeting held on 6th August 2019 were agreed as a correct record. Proposed by Mr P Fitch and seconded by Mr J Mackie.</p>	
5	<p>Matters Arising</p> <p>RIVER SPEY AND GARMOUTH BEACH – USE BY CAMPER VANS – It was noted that an e-mail had been sent to Camper Contact and Savilles have put up signs.</p> <p>GARMOUTH AND KINGSTON AMENITIES – COMMUNITY HUB – No further update on this item. It is hoped the community hub could become a collection point for Moray FoodPlus.</p>	
6	<p>Treasurer's Report</p> <p>In the absence of the Treasurer no report was available.</p>	
7	<p>Planning Matters</p> <p>MARCHFIELD – A planning application had been lodged for quarrying of building materials. It is believed this could be a retrospective application. It was agreed that Mr Fitch would investigate further and liaise with the Secretary.</p> <p>LAIGH HILL – The Enforcement Officer has been out five times, and will be keeping the site under inspection.</p> <p>TENNANT ARMS, LHANBRYDE – The new shop will open on 27th September 2019.</p> <p>MOSSTODLOCH ROAD/GARMOUTH ROAD – Improvements are being undertaken near the Primary School.</p>	PF/JM

11	<p>Merchant Navy Day</p> <p>The Secretary reported that the Northern Divisional Commander had attended the raising of the Red Ensign, together with the Sea Scouts. Thanks were noted to Mr C Dunbar for organising this.</p>	
12	<p>River Spey and Kingston Beach</p> <p>Updates were provided by Mrs McLennan and the Secretary in respect of this item.</p>	
13	<p>Locality Management Groups</p> <p>The Minute Secretary advised there were two of these Groups, one for East Moray and one for West Moray. Their emphasis is on Children and Families, and she agreed to circulate the presentation she had received.</p>	AM
