Rent Reviews

The Council deferred rent reviews due between 17 March 2020 and 31 August 2020 as a result of the coronavirus, but as part of the Council's re-instatement of services we are now proceeding to action rent reviews in the normal manner. Deferment of rent/Rent Rescheduling

Recognizing the country is moving through Phases 2 and 3 of the Scottish Government's recovery route map, at its meeting on 1 July 2020 the Moray Council Emergency Cabinet decided to recommence debt management processes with immediate effect. As such where temporary deferment of rent has previously been agreed with individual tenants Estates officers will shortly be touch with those tenants to arrange repayment of monies due.
