Telecommunications new fibre infrastructure is:				
 new fibre used for the purposes of facilitating the transmission of communications by any means involving the use of electrical or electromagnetic energy, 				
 a proportion of any poles, posts, towers, masts, mast radiators, pipes, ducts and conduits, and any associated supports and foundations on the lands and heritages, used in connection with new fibre, which proportion is to be apportioned in accordance of paragraph (3)(c), and 				
any parts of the lands and heritages which are exclusively occupied by new fibre.

 is 'new' if it was not laid, flown, blown, affixed or attached before 1 April 2019, 				
• is not 'r	new' if it replaces existing fibre, unless	it upgrades what was previously provided.
