RECORD OF DECISIONS AND ACTIONS OF
ZOOM MEETING 28TH MAY 2020

The FKCC held an informal ZOOM meeting on 28th May.

Present: Diane Anderson, Sue Dominey, Leah Fraser, Hamish Grigor (vice chair), Bob James (treasurer), Jen O'Hagan (minute secretary), Anne Skene (chair).

Apologies: None

Planning: there were three new planning applications – no objections:

20/00583/APP – Erect new metal fence at 185 Findhorn.

20/00587/APP – Kinloss Country Golf Club Plot18, modification of approved design and siting of temporary caravan.

20/00630/APP – Kinloss Country Golf Club, erect 4 houses.

Update from the Findhorn Village Conservation Company:

Stone Building and Coastal Rowers Shed (Engine Shed) - TFVCC have successfully applied and registered this building under Community Right to Buy. TFVCC wish to ensure that this historic central building will be retained for the village.

Car Parks - TFVCC have contacted the Moray Council to ask if/when the public toilets at the West Beach Car Park will be reopened - awaiting reply. Opening up of the car parks will depend on guidance from Scottish Government on Thursday 28 May. We are currently planning for when/if car park will reopen. If the lockdown is relaxed on Thursday to allow people to travel out with their local area TFVCC may open part of the car park for cars only, to stop cars parking on the road. Overnight parking will not be allowed. The three green bins at the west beach car park are being emptied weekly. Thank you to B James who volunteered to take to roadside for emptying.

Dunes Road will NOT be reopened at this time. TFVCC has made arrangements for bins on the dunes road to be emptied by Moray Council.

David Urquhart Path - The working group is in communication with the contractor and all going well work is hoped to re-start on Monday 01 June 2020.

SSE Award of £1000 to FKCC: for Covid 19 support to vulnerable people in the FKCC community and volunteer costs. It was decided that £500 be used in Kinloss and £500 in Findhorn.

ACTION: Contact the volunteer group leaders in each area - A SKENE

Right of Way: Condition of planning consent for Osprey House in 1996 but heavy gates placed at each end of pathway. No action by FKCC.

Fireworks on Dunes: Firework litter found; FKCC agreed to let landowners know due to concerns about fire risk during dry conditions.

ACTION: Inform Dunes Trust and TFVCC – B JAMES

Recruitment: It was decided to place an article/advert in the Forres Gazette to attract new members from Kinloss to join the FKCC. Two people from the Kinloss area would be invited to join. ACTION – A SKENE

Notice Boards - Phase 1-4: A summary of the Scottish Government exit route from lockdown would be placed on the CC notice boards.

AOB: H Grigor noted that Moray Council Planning Committee meetings had been suspended during lockdown. The MC Emergency Cabinet which has cross party and planning representation now deals with planning applications.
