- Police Update Nothing has been reported in the community safety report. Local reports of youths causing problems within the grounds of Tininver House. This has been reported to police. Clllr Laing said that once current rules allow, police will be doing the rounds in a pod for people to report their worries on local issues. She also mentioned that the setting up of a local neighbourhood watch may help.
- 2. Guest Speakers- DDCC welcomed John Wallace, Jessica Antas and Alison Hood from Startcraft Craig Watch windfarm project. The proposed project is for 18 200ft high turbines across the Aberdeen/Moray border. The timeline for the project was laid out, with the most recent phase including the consultation of local residents. It was discussed that all locals would be receiving letters and that if we can help with getting information across that would be really helpful. It was decided that Facebook and the Speirins would be the best route for us to help and that they provide a link for comments so people can have their say. DDCC were asked for comments and feedback and we felt that if lessons were to be learned from past projects full transparency should be the way forward. It was discussed that the previous placement of higher pylons than proposed had been an issue. Environmental impact with respect to the local residents should be a high priority. It was brought up why this area has such a high number of windfarms compared to other areas. It appears our geography and accessibility lends itself it such projects.
- **3. Minutes of last meeting-** The minutes were accepted as a true representation of the meeting. Proposed Joan, Second Anne.
- 4. Matters Arising-

Cabrach/Railway bridge problems-Following on from the answer about problems at both bridges recently. The DDCC did accept the answer that Moray Council can do little with the railway bridge other that an already declined traffic light system due to the geography of the area. The answer regarding the collision damage at the Cabrach bridge only being addressed if the culprit was found was not acceptable and we would request that this be addressed as a matter of urgency. Cllr Ross will pass this onto Moray council.

Fife Street Crossing- After complaints were received by Moray Council regarding parking over the Fife Street Crossing point, they requested changes be made in the form of a build out to match the other side. DDCC discussed the matter with some local residents and come up with a compromise solution. However our suggested compromise solution would not be an acceptable one and as such we have had to concede to agree to the safest option for the site. Although this will not acceptable to all it was felt that it has little impact on car parking (unless people park incorrectly as they are doing now) but provides the safest option for the community and visitors at the crossing point.

Tree Planting- DDCC plans to re-plant the lost trees at Masters Widd as part of the Countryfile project has been hampered by the recent landslide. This is in the process of being sorted but we have no news on when the road will reopen. Cllr Laing will find out if we are correct in thinking Moray Council own the land and if they will allow us to do this.
