Introduction

Retail, Hospitality Leisure and Aviation Relief is available to businesses which use properties in a class appearing in the list of Specified Purposes published by Scottish Government.

An award of 100% of the net rates payable in 2021-22 may be made to qualifying ratepayers.

Any decisions made regarding your application for relief will be made in accordance with the Non-Domestic Rates (Coronavirus Reliefs) (Scotland) Regulations 2021.

Qualification

An award of Retail, Hospitality, Leisure and Aviation Relief may be made if the following conditions are met:

- the ratepayer must be in rateable occupation;
- the ratepayer's property must fall within one of the classes of Specified Purposes stated in Schedule 1 to the 2021 regulations (<u>Note</u> – the list of classes of Specified Purposes may be found at http://www.moray.gov.uk/downloads/file136149.pdf); and
- an application for relief is submitted to the local authority (<u>Note</u>: a similar relief was awarded automatically in 2020-21, but the new regulations require an application to be made).
