2 **Police Update**

Insp GW provided an update on issues of note at this time. These included:

- Increase in gatherings of young people in the evenings, with cases of anti-social behaviour. This is being handled through an increase in foot patrols in the evenings and the disruption of behaviours. There is also a focus on educating young people.
- The Bike Register Initiative: this scheme (aimed at marking bikes with QR codes to allow any stolen bikes found to be returned to their owners) was oversubscribed, so more opportunities will be set up to allow people to book in to have their bikes marked and listed on the register. If there was sufficient demand in smaller locations (like Portknockie) it might be possible to set up a session in the village, but the need would need to be clearly identified and notified to Insp GW. There will however be centralised sessions in the future.
