Executive Summary

Transition Town Forres Ltd (TTF) was set up in 2008 and is a Social Enterprise, a Company Limited by Guarantee (SC346142) and a registered Scottish Charity (SC040314). TTF is a catalyst for groups and individuals who are working towards transitioning to a more sustainable future, providing space and resources that help to nurture activities, projects and new thinking across the Forres community.

Mission - To help secure our community's future through environmental education, sharing skills, knowledge, space, tools and renewable resources for common good.

We have two key strategic objectives:

- 1. Increasing the environmental awareness and health and well-being of the local community
- 2. Ownership and sustainable management of the Transition Centre.

TTF aims to take ownership of the Transition Center site at Bogton Road, Forres as this will give us security and long term resilience and enable us to expand our delivery of environmental and health and well-being outcomes. We are pursuing a Community Asset Transfer process with Moray Council and also working towards maximising income from hiring space at the Centre, enabling us to cover ongoing running and staff costs. We will focus on the Transition Centre providing a friendly, welcoming indoor and outside space, that is flexible and open with a holistic and sustainable outlook, and that acts as a catalyst for new ideas and partnerships.

In addition to the wide range of classes and activities that we will facilitate at the Centre, we have identified a number of future partnership projects that we will develop with local partners to make the very best use of the space. We will continue running existing projects - the Let's Eat and Well-being programmes will continue to work towards sourcing ongoing funding - and new projects like the Repair Café, the Therapeutic garden and Plant A will be developed.

Our recent community survey showed us that there are excellent opportunities to develop new partnerships with a wealth of creative and practical people across Forres. There is a strong interest in more classes, workshops and events, in hiring tools and e-bikes and in using the outside space. Our plan to take ownership of the Transition Centre site to give security and long term resilience to our activities, clearly fits with a wide range of local and national strategies and policies like the Moray Council Food Growing Strategy. It also helps us to address identified challenges for Forres, including higher levels of poor health, an older age profile, and higher numbers of people living alone.

This business plan articulates clear action plans for TTF as we work towards a Community Asset transfer of the Transition Centre site and develop our income streams and activities to give us long term resilience and sustainability.

1. Transition Town Forres

Transition Town Forres Ltd (TTF) is a Social Enterprise, a Company Limited by Guarantee (SC346142) and a registered Scottish Charity (SC040314), set up in 2008. TTF is part of a national network of Transition Towns and an integral part of TTF activity is to respond to the social, environmental and economic challenges faced by the Forres community. It achieves this by promoting and demonstrating ways in which people can live more sustainably and in harmony with their environment.

TTF is based at Bogton Road, Forres, where it has leased land and a building (the Transition Centre) from Moray Council for the last 12 years, at a reduced rent. This site is the Centre for TTF activity and also provides the home for a successful Community Garden, with around seventy growers currently using the site.

The Transition Centre is a catalyst for groups and individuals who are working towards transitioning to a more sustainable future. Through it we provide space and resources that help to nurture activities, projects and new thinking across the Forres community.

TTF Vision - To be integral to a vibrant and sustainable local community.

Mission - To help secure our community's future through environmental education, sharing skills, knowledge, space, tools and renewable resources for common good.

TTF is currently in a period of transition as an organisation, as we recognise the need to increase income generation and to move towards economic sustainability, whilst still delivering valuable environmental and health and well-being outcomes.

We have two key strategic objectives:

1. Increasing the environmental awareness and health and well-being of the local community This encompasses the delivery of Transition Towns outcomes, including:

- Fostering sustainability and resilience in the local community
- Reducing the dependence on non-sustainable fuels
- Encouraging and promoting health, choice and empowerment for local people
- Growing and promoting local, organic food
- Running activities and events to encourage community cohesion and reduce social isolation
- Providing space for groups and individuals to hire
- Supporting local suppliers and producers through collaborative events
- Working in partnership with local organisations and stakeholders
- Encouraging people to learn and make changes to their lifestyles
- Providing practical advice and guidance around reducing personal carbon footprints
- Appealing to the wider community and developing outreach activities across Forres.

2. Ownership and sustainable management of the Transition Centre.

This means generating sufficient income to cover Centre running costs, by:

- Maximising the rental of indoor and outdoor space at the Centre
- Running more one off events
- Marketing activities and opportunities widely
- Managing bookings and Centre activities effectively
- Ensuring cost recovery on TTF projects

- Applying for grant funding to cover lease, staff and running costs as appropriate
- Identifying methods of reducing costs in the long term.

This business plan addresses the delicate balance that must be struck between these two strategic objectives. It articulates the social, environmental and economic outcomes that TTF will deliver, whilst also illustrating how TTF will generate an income to cover the projected running costs of the Centre and the organisation.

A brief summary of our current projects is given below:

The Community Garden uses approximately half the land at the Transition Centre for community growing, delivering important health, well-being and environmental outcomes for local people and for Moray Council, specifically against The Moray Food Growing Strategy. The group has approximately 70 members, all of whom benefit from access to raised beds and growing space year-round. TTF covers the insurance and general maintenance costs and will be looking to increase members and income from this rental agreement in the future.

Let's Eat is a project run through TTF and is externally grant funded, paying a rental fee to TTF for the use of space. It delivers a number of free cooking & growing skills courses on a weekly basis for local people and is now a firmly established community project, having been running since December 2013.

The Wellbeing Project is also run through TTF and is externally funded, paying a rental fee to TTF for use of space. It provides free activity and education classes to people who are over 50, supporting physical, mental and social well being, as well as tackling social isolation. Classes include yoga, chair yoga, gentle exercise, crafts, up-cycling, drawing and mindfulness.

The Repair Café is an exciting new venture for TTF, working in partnership with the T-Exchange, a local group of technology enthusiasts. Members come together to help the public repair broken items, adhering to the repair and re-use ethos. The T-Exchange is looking to create a permanent base at the Transition Centre with long term hire of space for a community workshop.

Green Shoots is a planned collaboration with local primary schools. We anticipate communicating the vision and work of the transition network tailoring this to support curriculum and individual school needs and tying this in with the Scottish Government green recovery policies.

Therapeutic Garden a plan to utilise part of our existing space and create a designated therapeutic garden. Referrals from GP's and other health professionals and support organisations into a space designed to support those suffering mild learning disabilities, mental health issues, addictions and those suffering isolation.

Planet A a proposal to create youth led and managed plastic free and upcycled shop and cafe. Two containers to be obtained and converted by the group. The converted containers will house the shop and cafe with connection to Forres High St on demand using Trishaws.

Hire of Centre Space – TTF is working to increase the number and variety of groups hiring the unique space at the Centre for activities, classes, meetings and events. The community survey has evidenced that there is extensive interest in this, so we will upgrade promotion and booking systems to

maximise the opportunities.

A Part time Centre Manager is currently employed by TTF to oversee activity and ensure the smooth running of the Centre (8hrs per week).

A Development Officer TTF intend to appoint a Development Officer subject to a successful application for relevant funds from the Scottish Land Fund. This will give us the capacity to attract funding to develop the site and expand out range of projects and services. Research conducted by the Development Trusts Association shows that having core staff like this in place can bring in significant amounts of additional funding to the organisation, improve partnership working with other organisations and improve the general financial health of our organisation.

A volunteer coordinator/publicity manager TTF intend to make best use of an offer of voluntary work from an individual with a background in social enterprise work. Initially she will assist with the coordination of other volunteers. Once an independent coordinator has been secured she will work with our Centre Manager to maximise publicity. One of the key things identified in our Community Survey was that a significant percentage of the Community were unclear what precisely was happening at our location.

The community survey has shown that there are excellent opportunities to develop new partnerships with a wealth of creative and practical people across Forres to increase the environmental and health and well-being activities that we can offer from the Transition Centre. There is a strong interest in more classes, workshops and events, in hiring tools and e-bikes and in using the outside space.TTF ownership of the site and the ability to be the catalyst for new collaborations is the first step in this journey.

2. Lease/ Land ownership options

Through a recent strategic review, and as a result of the change to the rent charged by Moray Council for the use of the Transition Centre site, we have identified that a key decision must be made to achieve long term sustainability for the organisation. Moray Council charged a significantly reduced rent for the use of the site from 2008 to March 2020 (£4,000 including VAT). This was covered comfortably by income from activities and rental of space. From April 2020, the rent was increased to the market rate of £13,200 (confirmed by Shepherd valuation in November 2020). It was not possible for TTF to pay this rent through the current level of activity and therefore TTF considered a number of options. The pros and cons table below illustrates the thinking process and the final decisions made. A full options appraisal is provided in appendix 1.



TTF has discussed the options and decided to continue to rent the Transition Centre site, liaising with Moray Council regarding a potentially reduced rent and applying for grant funding towards rent costs in the short term. In tandem, we will pursue TTF ownership of the site through the Community Asset Transfer process and also work towards increasing income from activities and venue hire /rent to enable us to cover ongoing and increasing running and staff costs.

3. The Transition Centre Site

The TTF site is 0.93ha (2.3 acres) located at Bogton Road in the northeast of the town of Forres. It currently houses the Transition Centre building and Forres Community Garden, with additional outdoor space available for further use as required (marked in turquoise on the map below).






4. Community Needs Analysis

The Community Survey illustrates a strong need for our project to continue to deliver and expand services from the Transition Centre (see section 6). The need is also evidenced by the existing data from the Scottish Index of Multiple Deprivation, which shows that the central three data zones of

Forres score low in the SIMD analysis, particularly for employment, crime and education. These are marked red and orange on the map and sit within deciles 2, 3 and 4, so are in the lowest 20%, 30% and 40% of the overall ranking.



The Transition Centre is located just to the north east of these areas, and sits in decile 5, the lowest 50% of the overall ranking, and is easily accessed on foot from the centre of Forres. The Centre therefore has the potential to provide relevant educational activity and services that will benefit the most deprived people living within Forres.

The <u>Finalised Area Profile 2015 for FORRES (yourmoray.org.uk)</u> based upon 2011 census data (the most recent available), provides a number of insights into the specific needs of the community of Forres:

Population profile:

All Deciles

49.7% of the Forres population are over the age of 45, which is higher than Moray (46.6%) and Scotland (44.3%). In the ten years to 2011 (latest census data) Forres also saw an increase in population of 11%, with the proportion of over 60s rising by 5.6% to 27.6% overall. There are also a higher percentage of widowed, divorced, and single people potentially living alone, highlighting that social isolation and loneliness may be an issue. In addition, compared to Moray, Forres also has a higher proportion of residents who are retired, long-term sick or unemployed.

Health and Social Care

Slightly more (31.5% compared to 29.1% in Moray) of Forres residents have one or more long term health conditions and a higher incidence of depression than in Moray or Scotland as a whole.

- 896 (9%) of Forres residents provide care to either a friend or family member.
- Nearly 56% of those who carry out unpaid care in Forres provide 1 to 19 hours of care a
 week.
- 259 (2.6%) of residents in Forres provide over 50 hours of care per week, which is higher than the Moray rate and fractionally higher than the national rate.

Forres has a higher percentage of single occupant households (34.7%), (Moray 30.1%, Scotland 34.7%). Forres also has 25.1% of households where residents are above the age of 65. The Moray Council analysis suggests that this may have an impact upon social care, as any needs would be less likely to be met by either family or friends.

The Moray Food Growing Strategy also highlights specific health related issues in Moray:

The economic cost of mental health problems in Scotland is estimated at £10.7 billion.



For Moray this equates to around £172 million.

Overall, these statistics illustrate the need for the Forres community to have good access to health and well-being services such as those provided by TTF.

In addition to this, the nature of the Transition Centre site, which promotes outdoor growing activities through the community garden and has associated education courses planned, directly impacts upon the health and well-being of attendees as evidenced in recent research:

Why gardening makes us feel better / RHS Gardening A King's Fund report on the health benefits of gardening showed significant reductions in depression and anxiety were one of the benefits of regular gardening. Gardening report formatted (kingsfund.org.uk).

The RHS Science Strategy also makes a strong case for the importance of gardening for mental health Mental health and wellbeing – How gardening can help / RHS Gardening.

5. How community asset ownership will enable TTF to respond to challenges

The key challenges identified for the Forres community from the statistical data can be summarised as:

- Slightly higher levels of poor health
- An older age profile
- Higher numbers of people living alone and potentially socially isolated.

It is also noted from the SIMD statistics that there is a significant difference in deprivation across Forres, with some areas experiencing very high levels of deprivation whilst others are not unduly affected, leading to localised inequality.

On a wider basis, the overarching challenge to be tackled by TTF and the community worldwide is climate change.

TTF is addressing these challenges in a number of ways:

Environmental education – The Transition Centre activities will help to secure Forres community's future by sharing skills, knowledge, space, tools and renewable resources to enable people to change their lifestyles and move towards more sustainable activities for the common good:

- Increased local knowledge, understanding and action to tackle environmental challenges
- More sustainable lifestyles

Supporting people limited by poor health and tackling social isolation – by working with partners to deliver health and well-being activities and providing social groups and opportunities to meet informally:

- Increased social opportunities for older people and those with health issues
- Reduced social isolation
- Improved health and well-being

Providing activities and opportunities for engagement for people, including informal learning and social activities that increase confidence and skills:

- Increased social opportunities for older people and families.
- Increased activities and opportunities for engagement
- Increased confidence and skills.

Tackling inequality - by bringing people together socially and delivering projects for the benefit of the whole community, including intergenerational activities and opportunities to volunteer, so sharing skills and experiences.

6. Strategic Fit

Transition Town Forres (TTF) proposal to take ownership of the Transition Centre site to give security and long term resilience to our activities, clearly fits with a wide range of local and national strategies and policies as summarised below. Further detail is provided in Appendix 2.

Forres

Forres Community Plan 2020

Environment and Sustainability was the top priority highlighted through the extensive community consultation leading to the Forres 2020 Community Plan. Transition Towns Forres was identified as a partner in delivery for the key actions under this theme, which included planting of trees, orchards and to encourage wildlife. The Community Garden is also highlighted as a community green and open space within this document.

Moray

Moray 10 Year Plan Local Outcomes Improvement Plan

Moray Community Planning Partnership is 'raising aspirations by creating an enabling environment where our residents can achieve expanded choices, improved livelihoods and wellbeing'.

The 10 year Plan (2016-26) is working towards the following four priorities:

- 1. Growing, diverse and sustainable economy;
- 2. Building a better future for our children and young people in Moray;
- 3. Empowering and connecting communities;
- 4. Changing our relationship with alcohol

TTF can actively contribute towards the first three of these from a secure and sustainable base, which will enable it to grow services to include:

- Social activity through cookery, well-being and growing classes
- Specific events and activity for older and younger people
- Networking and resource sharing projects
- Environmental information and education to support more sustainable lifestyles.


Moray Council is specifically monitoring and reporting against a wide range of outcomes, including waste diverted from landfill and energy consumption. These are targets that TTF's environmental and sustainability education activity has the potential to directly impact upon as we expand our activities and outreach work.

Moray Food Growing Strategy - Moray Council

The Community Empowerment (Scotland) Act 2015 requires each local authority to prepare a food growing strategy. The Moray Food Growing Strategy aims to ensure there are more opportunities for people who would like to grow their own food to do so. Moray Council is committed to working with local partners and organisation to support the delivery of the wider benefits associated with food growing including:

- Improving health and wellbeing
- Promoting opportunities for social interaction
- Encouraging sustainability including addressing climate change, enhancing biodiversity and reducing food waste
- Promoting skills development and education
- Creating opportunities for economic development

This document highlights the benefits of growing food locally as illustrated above, and includes The Community Garden at Bogton Road specifically as an existing Community Garden:



TTF is currently managing the Community Garden site and through this, together with the comprehensive Let's Eat programme, is delivering directly against all the objectives of the Moray Food Growing Strategy: Health and Well-being, Education, training and support, Sustainability and delivery of land.

The recent rent rise has put the continuation of these activities at severe risk and TTF is working hard to find an alternative solution to ensure that TTF and the Community Gardens can continue to play a valuable part in the delivery of this Strategy.

The Strategy states that one of the Actions is to 'Work in partnership with third sector partners to promote, volunteering, community harvesting and sharing, community composting, equipment sharing and skills sharing'. This would appear to be an ideal opportunity for Moray Council to work closely with TTF to find a solution to securing the delivery of these outcomes, potentially through Community Asset Ownership.

Scotland

Scotland's Economic Strategy (March 2015) sets out four Key Priorities for Scotland: Investment, Innovation, Inclusive Growth, Internationalisation. These are all influenced by two overarching themes: Tackling Inequality and Competitiveness.

The proposed TTF asset transfer is a community facilities project that directly adheres to the aims of the Inclusive Growth priority and also tackles inequality, by delivering an important service for a local community. The recognition that the organisation needs to become sustainable in the long term, and less reliant upon grant funding is also in line with the direction of the Scottish Economic Strategy, growing opportunity and sustaining services long-term.

Scottish Government's support for projects such TTF's proposed asset acquisition and the benefits it recognises can be achieved through projects such as this is illustrated below:

'There is a vibrant and diverse range of community-led initiatives....... The work of these groups is having an impact from our islands and remotest rural villages to the hearts of our cities and towns.....' (March 2015, Communities, local assets and housing)

The Scottish Government Health Policy (2017) recognises that encouraging people to be more active could help prevent and treat more than 20 chronic diseases, increase life expectancy and reduce pressure on the NHS. The sustainable community growing resource, education and support provided by TTF supports gardening activity across all ages.

Community Land Scotland clearly articulates the rationale for communities purchasing assets on its website, as do several pre-purchase communities that are striving for similar outcomes to TTF: "Owning our local assets and managing them will create more opportunities for people to work together and develop a sense of local ownership and responsibility. A stronger and more sustainable future is a key driver behind our buyout aspirations." Pre-purchase community.

The new Scottish Government Social Enterprise Action Plan – Inclusive growth through social enterprise 2021-2024 states "Social Enterprises across Scotland are characterised by kindness and compassion...now more than ever, we need a strong and resilient social enterprise sector to help move Scotland forward".

It illustrates that the government sees social enterprises playing a key role to reduce inequality, support healthy communities and deliver an inclusive, wellbeing economy.

Key themes include **Climate emergency** and the plan notes "we will introduce measures that will enable and support the social enterprise sector to lead by example in combating climate change." Community wealth building (CWB) is a people-centred approach to local economic development, which redirects wealth back into the local economy, and places control and benefits into the hands of local people. Three of the five core principles are directly related to TTF taking ownership of the Transition Centre site and help to show specifically how TTF will be working towards community wealth building through its local growing and reuse/repair ethos:

- Shared Ownership of the Local Economy supporting and growing business models that are more financially generative for the local economy.
- Socially Just Use of Land and Property developing the function and ownership of local assets held by anchor organisations, so local communities benefit from financial and social gain.
- Making Financial Power work for Local Places increase flows of investment within local economies by harnessing and recirculating the wealth that exists.

The Scottish Government

Specific recommendations made by the **Just Transition Committee** around empowering local communities:

Empower and invigorate our communities and strengthen local economies-An inclusive transition ensures people have a say in climate action and strengthens local economies. A just transition is shaped by Scotland's citizens, not imposed on them. It energises social partnerships and local democracy and develops places and communities that are designed for net-zero and improved wellbeing. It empowers consumers to choose local, sustainably produced food and drink

And the **2018-2032 Update to climate change plan** which includes a commitment to "a 'green recovery' from COVID-19, one which captures the opportunities of our just transition to net zero. That means creating green jobs, developing sustainable skills and nurturing wellbeing. This approach recognises climate change as a human rights issue and the transition to net zero as an opportunity to tackle inequalities."

International

As part of a national network of <u>Transition Towns</u>, an integral part of TTF activity is to respond to the social, environmental and economic challenges faced by the Forres community by promoting and demonstrating ways in which people can live more sustainably and in harmony with their environment. We do this through education, collaboration and providing resources and activities that help people to move towards sustainability. This work directly contributes towards the UN Sustainable Development Goals, in line with Scottish Government strategy.

7. Community Consultation and Engagement

A community survey was undertaken during March and April 2021 on behalf of TTF, which included an online campaign and a door drop postcard to every house in Forres. A total of 383 surveys were collected, which is a 5% sample of the households in the area.

Most people who completed the survey were aware of Transition Town Forres and their activities. They showed a high level of support for the TTF aims of promoting sustainable lifestyles and systems to create a more resilient local economy.



One of the main themes that came out of the survey was the support for using the facilities as a community resource. There were a huge range of suggested activities that could take place both indoors and outdoors, covering areas from yoga and drumming to cookery and gardening.

We suggested the main room as an area that could be rented. 190 people were interested in using the space, mainly for one off events and meetings. The majority were willing to pay £10 an hour, some were happy to pay up to £20 per hour. Other charging structures were suggested in the comments, including a daily charge and a percentage charge on the income from any courses.


Other income generating activities included hire of a hot desk or office space. Community workshop space hire attracted more interest, with suggestions of between £10 to £60 a month spend. 26 people left contact details to show their interest. The tool library suggestion was also popular and would work well with a workshop space.

We also asked if people would be interested in running a business, social enterprise or event from the site. 45 people were interested in hiring outdoor space on the site, mentioning craft fairs, farmers markets and events. 35 people were interested in hiring workshop/container/cabin space, mentioning training, repair and maintenance projects.

The community garden was important to the survey respondents; 72% showed an interest in the expansion of facilities in this area. Gardening classes and workshops were also mentioned regularly in the comments sections.

77% of the survey respondents support TTF purchasing the land from Moray Council via Community Asset Transfer (CAT). Only 11% opposed this action, but it should be noted there were several strong comments against the CAT.

Several organisations and many individuals used the open comments section at the end of the questionnaire to offer their support for this project. There were also a few negative comments around the purchase of Common Good Land by TTF, with misunderstandings of the charity's purpose, for example as



having something to do with Findhorn, and suggestions of collaborations that already exist, where these had not been mentioned in the survey by . See Appendix 4 for full details.

8. Options Appraisal for Activity Development

The community survey and market assessment has shown us the activities and space the local community wants to access at the Transition Centre. The options appraisal below is informed by this feedback together with TTF and stakeholder discussions and has been used to build the Activity Plan in section 8 and to estimate the income streams in the financial tables.

Summary of TTF decisions re delivery

- As a priority, TTF will Promote the Transition Centre space for hire to partners to deliver
 activities and services, marketing it to a wide range of organisations. The community survey
 has identified a range of people and organisations who are keen to deliver activities in the
 space and these will be followed up by TTF in the near future.
- TTF will also continue running the existing 'inhouse' projects, as funding allows. The Board members leading the Let's Eat and Well-being programmes will continue to work on sourcing funding for ongoing programmes.
- New project development will be carried out in partnership with other organisations and led by TTF Board members with volunteer support e.g. Repair shop/upcycling shop, Tool library, Electric bike hire, Community composting scheme.
- Hot desks and office space for hire will not be promoted specifically, as the office space available is limited. However, there is flexibility if a suitable partner wishes to rent a small amount of office space and access can be enabled simply.
- Permanent artist work space is not possible within the Centre building, although outside space to be used for containers / sheds can be rented to artists/makers and this option will be made available (subject to planning discussions).
- Outside space will be made available for rent for a variety of uses, including growing, polytunnels, containers and sheds for partners. TTF will plan the space and access requirement, to include space for small farmer's and craft markets, and approach the planning department to establish any planning requirements. Partner organisations will fund any infrastructure in phase 1, to minimise capital costs for TTF.
- TTF will not invest in infrastructure (containers, polytunnels etc) in phase 1, as all efforts will be on raising match funding for the purchase and covering current running costs. This will be reviewed from phase 2 onwards.
- The current rental fees for the Community Garden will be increased to cover a small proportion of the rent increase being paid by TTF.
- TTF will work towards delivery of 'paid for' courses and activities and an outreach programme in phase 2, once a development officer is in place.

The full options appraisal is provided in appendix 3.

9. Activities Plan and Potential Growth

Indicative weekly activity plan for the Centre:

This indicative activity plan is based upon current and proposed new activities. Times and days are indicative only, but illustrate the level of expected use of the transition Centre.

From the community survey, answered by over 380 people, the most popular activities to be accessed at the Transition Centre were:

68% Community events

66% Environmental / Nature classes

63% Repair café

63% Gardening courses

60% Climate change & local resilience conversations & advice

Just based upon the responses to the survey, this indicates that around 260 people would be likely to attend community events. The repair cafe could expect to be supported by approximately 240 people and environmental, nature and gardening courses are likely to be of interest to around 240 people overall, so sessions run several times a week could easily have a regular attendance of 10 people. This means that the Transition Centre spaces could be used at least three times a day, seven days a week, with an effective promotion and booking system. Current income from room bookings is approximately £5,000, and this is projected to increase significantly to around £20,000 per annum with the increased focus on promotion and engaging with partners. (See section 15 and appendix 11 for financial tables).

The table below gives indicative use of the Centre and illustrates approximately how the proposed activities would fit into the time available. Within each heading, there are a number of sub activities, which, once booked as blocks of 10 classes, can be expected to provide a full programme of activity at the Transition Centre.

TTF will now contact and work with each of the providers who gave contact details in the survey, to establish availability and class times and dates, so building a programme of courses and activities for the Forres Community. TTF will also be contributing significantly towards the activity programme through Let's Eat, the Well-being Programme and volunteer-led talks and conversations around transitioning and the environment.

In tandem with the weekly activity programme, TTF will coordinate and rent out space long term to facilitate indoor and outdoor growing, the repair shop and tool library, electric car and bike hire, workshop space and Farmer's markets/craft fairs at the Centre.

The clear support and interest from a significant number of people within Forres for the Transition Centre and the activities it can offer, together with the increased promotion and co-ordination of hire activity planned by TTF, will serve to increase the income stream and sustainability of TTF. The result will be a vibrant and engaging Centre of activity welcoming all and providing support, interest and social contact for a wide range of people within the Forres Community.

10.Site Development

There is unused outdoor space currently available at the site, which will be used for additional storage, containers, sheds and polytunnels in the future. This also provides the opportunity to create more growing space. TTF will work closely with partners to plan the most appropriate developments to achieve our two key objectives:

- 1. Increasing the environmental awareness and health and well-being of the local community
- 2. Ownership and sustainable management of the Centre

We are currently focussed upon raising the funding required to purchase the site, to increase staff time and to stabilise the income and expenditure over the next three years. Therefore, we do not envisage carrying out any significant site developments that will incur costs for TTF over the next three years. However, we will liaise with partner organisations that can deliver environmental or health and well-being outcomes through activities on the site, enabling and supporting their needs for practical storage, access etc. There is potential, for example, for the Community Repair workshop to create additional storage by siting a storage container or shed behind the main building. TTF will support this by working in partnership with T-Exchange, with T-Exchange taking the lead on fundraising for the purchase and siting of suitable resources. TTF will take the lead on funding for our youth led project which will also require the purchase of two containers. There is ample room for 4 containers on site. The estimated capital cost table below indicates an estimate of £10,000 required to provide four storage containers on site. This could be achieved through grant funding applications and is likely to take place over the next eighteen months.

11. Partnerships and Project Development

TTF is focused upon supporting and empowering members to create and manage their own projects in line with TTF's overarching vision and objectives. To this end, we are developing cross sector partnerships, working towards a sustainable food economy and increasing our engagement with the community. In addition to the wide range of classes and activities that we will facilitate at the Centre, we have identified a number of future growth projects that we will develop with local partners to make the very best use of the space, each with a lead Board Member. This work will dovetail with our expansion of the use of the Centre and lead to rental / hire income for projects as they grow. Further information about TTF partnerships and future project development is provided in appendix 5.

12. Outputs and Outcomes

These outputs and outcomes illustrate that significant community and environmental benefit will be achieved through the ownership and ongoing use of the Transition Centre site by TTF. There is also an additional community benefit from TTF purchasing the Transition Centre site from Moray Council, as the purchase price will be added to the Common Good Fund and used to contribute towards community projects across Moray.

13.TTF Structure

Company Structure and Delivery

Transition Town Forres Ltd is a Company Limited by Guarantee (SC346142) and a registered Scottish Charity (No SC040314). TTF was set up in 2008 and is part of the wider Transition Network, which focuses on responding to challenges including climate change and peak oil, through local action to help people to transition to a more sustainable future. Over the past 12 years, TTF has delivered activities to raise awareness of the global issues affecting the town of Forres, helping local people take personal action in response to these.

The organisation is led by a Board of five local people, bringing a high level of relevant skills, together with an experienced Centre Manager employed for one day a week currently. TTF recognises that in order to develop income streams and grow activity, we need to increase the paid staff time that we have available. As we pursue the Community Asset Transfer of our current site, we have amended our constitution with the support of COSS to ensure that TTF is an eligible community body for ownership of the asset.

TTF Board and Staff Skills

The TTF Board Members and staff completed a skills audit to highlight areas of strength, where skills can be shared, together with gaps that need to be filled. The collated results show strong skills in the majority of areas required to deliver TTF services and activities, including taking ownership of the Centre. In particular, TTF has a high level of skills and knowledge in planning and organising community activities, community engagement, environmental sustainability education, health and well-being and food growing and cooking.

The team possess good skills in funding applications, governance, board responsibilities, staff management, communications, health and safety and partnership development. There is an opportunity to share skills across Board members within these areas through informal Board skill share sessions.

Further expertise would be beneficial to TTF in financial management, monitoring of outcomes, marketing and facilities management. These skills could be developed through recruitment of new Board Members and potential training for current Board Members and staff.

The Board have now been able to secure an offer of volunteer employment which increases available support time by a significant 20 hours per week. Work will be done to recruit additional volunteers. Volunteers will help run projects. Recruitment of additional Board Members to complement skills and add capacity continues to be desirable

The collated Skills Audit results and Board Biographies are provided in appendices 7 and 8.

14. Operational Model

TTF has developed a clear strategy to achieve our two key objectives:

- 1) Ownership and sustainable management of the Centre
- 2) Increasing the health and well-being and environmental awareness of the local community

We have established that there is strong community support and interest in the potential for TTF to take ownership of the Transition Centre site and use it to develop and offer a wide range of environmental and health and well-being activities, courses and events (89% of the survey respondents were in favour). We will therefore progress the Community Asset Transfer and continue engaging with the community as we progress.

We will immediately increase the promotion of renting indoor and outdoor space at the Transition Centre, co-ordinating bookings and building a comprehensive activity programme in conjunction with our partners. This will focus on the Centre's USP – providing a friendly, welcoming indoor and outside space, that is flexible and open with a holistic and sustainable outlook and acts as a catalyst for new ideas and partnerships.

We will update our pricing and booking policies to ensure clarity and fairness and to provide TTF with the opportunity to cover all overheads and increase management staff time in 2023. All TTF projects will be run on a full cost recovery basis as they are currently, with rental for space and overheads being paid monthly. This will be necessary to continue to grow and manage the Transition Centre and will provide the opportunity for phase 2 development work into outreach work.

The comparator prices in appendix 13 indicate that a standard rate of £15 per hour for hire of the Centre is appropriate. We will reserve the option to offer a reduction in price to £12 per hour for regular users (for example book at least 6 sessions) and charities. The financial tables are currently based upon £15 per hour, together with a conservative estimate of weekly bookings. We will monitor this and facilitate reductions as appropriate, ensuring that running costs are covered. TTF will be responsible for promoting the space and managing marketing, bookings, coordination and cleaning to ensure a smooth running and repeat business. This will be carried out by the Manager predominantly, with TTF Board members taking responsibility for grant funding, Community Asset Transfer and volunteer recruitment and management at this point in time.

Staff resource

TTF currently employs a Manager for 8 hours per week and a part time cleaner.

We have identified the need for a **Development Officer**, to:

- Increasing number of users and subscribers to the centre and its projects
- Investigating potential incomes streams and funding opportunities
- Maximise the use of the venue and other assets
- Identifying partnership opportunities with local organisations and stakeholders including elected members
- Developing and delivering communication and marketing strategies
- Identifying and supporting project funding applications

The financial model is based on the assumption that TTF will make a successful application to the Scottish Land Fund in relation to the first years costs of a development manager. The development created will provide a sustainable future. The development officer would facilitate the increased marketing, engagement and partnership working required to achieve the desired outcomes.

Volunteers

All of the TTF projects require volunteer support, so as an integral part of TTF's development, we will aim to recruit more volunteers to work with us across our activities. The strong support for TTF shown by the community survey indicates that we are likely to be able to recruit volunteers for specific tasks.

We have a Volunteer Policy in place (appendix 6) and we will develop specific volunteer role descriptions for projects as they develop, recruiting people directly to fill the requirements we identify. In the future, we aspire to employ a Volunteer Recruitment Officer to support us in the development of this aspect of our work.

Communications

We will continue to maintain a high level of open communication with the community through social media and our website in particular. We have increased our membership to over 250 this year, and as we move forward, we will be increasing our visibility and engagement to recruit new volunteers, Members and Board Members to TTF. A draft Communications Strategy is provided in appendix 10.

15. Proposed TTF Action Plan for Implementing Phase 1 and 2 (years 1 to 5)

Year 1 April 22-March 23

Centre Manager actions:

- 1. Focus on increasing marketing and rental of the Centre building and outside space -
- Contact all leads from the community survey re bookings and hire of space
- Implement new rental policy once put in place by Board
- Market indoor and outdoor space to all groups and manage bookings
- Revisit bookings system and ensure fit for purpose
- Facilitate hot desk and office space hire as appropriate
- Liaise with partners/gardeners/makers/artists re use of outside space and requirements
- Aim to generate sufficient income to cover running costs, including increased rent to Council for 2021-22.
- Check operational processes and policies building management, cleaning, access, security, covid safety
- Update and develop the activities plan for the Centre and advertise widely, showing how the Centre is used on a weekly basis and encouraging wider engagement.

TTF Board actions:

- Review all current rents for inside and outside space and agree prices going forward (£15 per hour is used in financial model) and set a new rental policy
- Clarify outdoor space available for rent and carry out spatial planning exercise for use of all outside space going forward (may require professional input)
- Liaise with planning department re use of outside space and permissions required
- Engage with the wider community through volunteer run events and activities (liaise with Centre Manager re use of space)
- Initiate community fundraising towards new projects (match funding may be required)
- Include all planned activities and events in the community activities plan
- Apply for small grant funding to subsidise events and activities as appropriate
- Continue to deliver existing inhouse projects if grant funding can be sourced
- Develop CAT asset transfer request, liaising with Moray Council and DTAS
- Develop SLF application.

Phase 2, Years 2-5 - April 23 to March 26

Centre Manager actions:

 Ongoing marketing and rental bookings (aim to cover running costs completely and increase income to cover staff costs)

Development Manager actions:

- Develop paid for events and activities programme to be run by TTF centrally (speakers, evening food events etc.) aim to generate some income for TTF
- Take on organisation and implementation of community events programme, building upon Board activity from previous year (requires additional paid hours)
- Investigate potential of running Farmers Market / Makers Market on a regular basis (e.g. monthly)
- Develop community education and outreach programme, working with Board members for voluntary delivery as appropriate (requires additional paid hours)
- Develop and support new TTF inhouse projects as appropriate
- Apply for grant funds to deliver TTF projects
- Generating early income using educational/ hub resources
- Develop TTF Education and outreach programme in conjunction with Centre Manager
- Build partnerships with other organisations

TTF Board actions:

- Plan for SLF grant being awarded
- Plan for Community Asset Transfer completion and TTF ownership of asset from end 2022
- Monitor income and expenditure carefully
- Ongoing community engagement Work with TSI and Councilors to make necessary links and promote TTF widely
- Deliver community education and outreach programme as volunteers, as appropriate
- Wider partnership and stakeholder development resulting in new external projects on site
- Consider container options and implement if market identified
- Develop new TTF inhouse projects as appropriate
- Apply for grant funds to deliver TTF projects
- Develop TTF Education and outreach programme in conjunction with Development Manager
- Expand polytunnel and use of outside space to include container siting requires capital investment – check markets exist and grant funding can be sourced
- Revisit all activity and plan strategy going forward if increased space required consider further asset transfer application for adjacent land

Assumptions:

- The TTF development manager role subject to funding from SLF will begin from April 2023.
- Early input from a development manager will allow income generation from advice sessions and speakers.
- Running costs of the site are based on current figures with a 3% annual increment.
- The model assumes that the CAT transfer process takes until April 2023 to finalise, so rent payments are included to March 2023.
- TTF ownership of the site from April 2023, with no rent or water rates from that point.
- The cleaning budget includes the cost of a part time cleaner.
- Part of the container purchases may be funded by a partner organisation.
- Income from activities relates to the detailed spreadsheet in appendix 11 the baseline is highlighted in yellow. £6000 is the assumed income by the end of 2022 with losses from COVID included, based on usage to date.
- Our addition of a Development manager in early 2022 will allow us to maximise use of our indoor space at a rate of £15 per hour, 5 hours per day, 5 days per week, 40 weeks per year.
- The addition of a Development manager will allow us to maximise income for outdoor assets such as our electric vehicle charging point and the tool hire facility.
- Estimates of outdoor space hire are based on our community survey (details in Appendix 4), which reported for instance that out of 377 people who answered a question of whether

they would register with a tool library, 172 responders said yes and 121 said maybe. Rates are taken from the suggested annual donations of Edinburgh and Stirling tool libraries at £30 per year with a conservative starting point of 170 members. The table does not provide detailed room for likely major growth of this project in particular and assumes the steady 3% per year.

A low level of regular TTF fundraising is required to maintain the financial model.

17. Funding Opportunities

TTF may need to raise funding to cover a percentage of the purchase price of the land. We also need to cover future development costs of the site. These plans are conditional on funding being obtained. We will approach the following funding streams to help us to do this and run a local community fundraising campaign.

Moray Common Good Fund

TTF has applied to the Common Good Fund to cover the rent on the site for the past two years (2020 and 2021). A further application for 22-23 rent may be required if the CAT process has not completed within that time. Common Good Fund (moray.gov.uk)

Moray Council currently holds £50,901 of Developer Obligations funding to be spent on Community Facilities within the Forres Academy catchment area. We anticipate this fund will prove a good fit for our planned therapeutic garden.

Newbold Legacy Trust Informal communications indicate that this trust when open will support youth-led project and we anticipate our Planet A will be the type of project supported by the Trust.

The National Lottery Together for Our Planet fund

TNL are offering from £1,000 to £10,000 of National Lottery funding to support communities across the UK to take action on climate change.

The Berry Burn Community Fund receives an annual budget of £190,000 from international renewables company Statkraft, whose 29-turbine wind farm lies between Forres and Grantown-on-Spey. The fund is overseen by eleven volunteer members, living and working within its operational boundary. The annual budget is spread over three awards rounds each year.





Moray Food Growing Strategy - Moray Council





TTF is currently managing the Bogton Community Garden site and through this, together with the comprehensive Let's Eat programme, is delivering directly against all the above objectives of the Moray Food Growing Strategy.

The recent rent rise has put the continuation of these activities at severe risk and TTF is working hard to find an alternative solution to ensure that TTF and the Bogton Community Gardens can continue to play a valuable part in the delivery of this Strategy.

The Strategy states that one of the Actions is to 'Work in partnership with third sector partners to promote, volunteering, community harvesting and sharing, community composting, equipment sharing and skills sharing'. This would appear to be an ideal opportunity for Moray Council to work closely with TTF to find a solution to securing the delivery of these outcomes, potentially through Community Asset Ownership.

Scotland

Scotland's Economic Strategy (March 2015) sets out four Key Priorities for Scotland: Investment, Innovation, Inclusive Growth, Internationalisation. These are all influenced by two overarching themes: Tackling Inequality and Competitiveness.

The proposed TTF asset transfer is a community facilities project that directly adheres to the aims of the Inclusive Growth priority and also tackles inequality, by delivering an important service for a local community. The recognition that the organisation needs to become sustainable in the long term, and less reliant upon grant funding is also in line with the direction of the Scottish Economic Strategy, growing opportunity and sustaining services long-term.

Scottish Government's support for projects such TTF's proposed asset acquisition and the benefits it recognises can be achieved through projects such as this is illustrated below:

'There is a vibrant and diverse range of community-led initiatives........ The work of these groups is having an impact from our islands and remotest rural villages to the hearts of our cities and towns......' (March 2015, Communities, local assets and housing)

The Scottish Government Health Policy (2017) recognises that encouraging people to be more active could help prevent and treat more than 20 chronic diseases, increase life expectancy and reduce pressure on the NHS.

Government actions to promote physical activity include promoting opportunities for improving people's health through a 10-year physical activity implementation plan.

The Government's <u>Active Scotland Outcomes Framework</u> sets out how they will support increased activity in Scotland:

- We encourage and enable the inactive to become more active, and stay more active throughout life
- We develop physical confidence and competence from the earliest age
- We improve our active infrastructure people and places
- We support wellbeing and resilience in communities through physical activity
- We increase opportunities to participate, progress and achieve in sport.

These actions are supported by TTF providing a sustainable community growing resource to support gardening activities across all ages, together with the wide range of health and well-being activities that are delivered at the Centre.

Community Land Scotland clearly articulates the rationale for communities purchasing assets on its website, as do several pre-purchase communities that are striving for similar outcomes to TTF:

"Owning our local assets and managing them will create more opportunities for people to work together and develop a sense of local ownership and responsibility. A stronger and more sustainable future is a key driver behind our buyout aspirations." Pre-purchase community.

The new Scottish Government Social Enterprise Action Plan – Inclusive growth through social enterprise 2021-2024 is part of the 10 year strategy for social enterprise 2016-26, which sets out the Scottish Government's ambitions for social enterprise in Scotland, jointly developed with the sector. It supports the Government aims of sustainable economic growth, tackling inequalities and building a fairer Scotland. It is intended to raise the profile of social enterprise activity and demonstrate its value, opening up markets and increasing the range of finance available to develop the trading capacity of social enterprises.

Recognising the positive outcomes that can be achieved by social enterprises is an important step to them becoming an integral part of the delivery of facilities and services within communities. TTF is a social enterprise that is moving towards a more independent financial situation through earned income, increasing sustainability and the potential for long term resilience.

Then Action Plan states "Social Enterprises across Scotland are characterised by kindness and compassion...now more than ever, we need a strong and resilient social enterprise sector to help move Scotland forward".

It illustrates that the government sees social enterprises playing a key role to reduce inequality, support healthy communities and deliver an inclusive, wellbeing economy.

Key themes include **Climate emergency** –The plan notes "we will introduce measures that will enable and support the social enterprise sector to lead by example in combating climate change." Diversity, trading, funding, and Building place – "Creating the conditions where place-based social enterprise activity and communities can flourish, through enhanced promotion, developing capacity, and funding." Community-led regeneration through Community Wealth Building is also emphasised in the plan.

<u>Community wealth building</u> (CWB) is a people-centred approach to local economic development, which redirects wealth back into the local economy, and places control and benefits into the hands of local people.

Three of the five core principles are directly related to TTF taking ownership of the Bogton Road site and help to show specifically how TTF will be working towards community wealth building through its local growing and reuse/repair ethos.

- Shared Ownership of the Local Economy supporting and growing business models that are more financially generative for the local economy.
- Socially Just Use of Land and Property developing the function and ownership of local assets held by anchor organisations, so local communities benefit from financial and social gain.
- Making Financial Power work for Local Places increase flows of investment within local economies by harnessing and recirculating the wealth that exists.

The Scottish Government

Specific recommendations made by the **Just Transition Committee** around empowering local communities:

Empower and invigorate our communities and strengthen local economies-An inclusive transition ensures people have a say in climate action and strengthens local economies. A just transition is shaped by Scotland's citizens, not imposed on them. It energises social partnerships and local democracy and develops places and communities that are designed for net-zero and improved wellbeing. It empowers consumers to choose local, sustainably produced food and drink

And the **2018-2032 Update to climate change plan** which includes a commitment to "a 'green recovery' from COVID-19, one which captures the opportunities of our just transition to net zero. That means creating green jobs, developing sustainable skills and nurturing wellbeing. This approach recognises climate change as a human rights issue and the transition to net zero as an opportunity to tackle inequalities."

International

As part of a national network of <u>Transition Towns</u>, an integral part of TTF activity is to respond to the social, environmental and economic challenges faced by the Forres community by promoting and demonstrating ways in which people can live more sustainably and in harmony with their environment. We do this through education, collaboration and providing resources and activities that hep people to move towards sustainability. This work directly contributes towards the UN Sustainable Development Goals, in line with Scottish Government strategy.

In line with the UK being a signatory to the **UN Sustainable Development Goals**, Scottish Government commitment to working towards sustainability is expressed in a number of national-level strategic statements. In particular, **Scotland's Economic Strategy**¹ and the **Economic Action Plan 2019-20**² acknowledge the challenges and opportunities faced in sustaining communities and livelihoods, including the need to tackle climate change and better manage natural resources. This is further highlighted in the accompanying **Environment Strategy for Scotland**³, which outlines links between better management of natural capital and the full range of National Outcomes listed under the **Scottish National Performance Framework**⁴.

These over-arching perspectives are reflected in various more specific strategies and plans focusing on particular themes or sectors. For example, the **Climate Adaptation Programme**⁵, and **Making Things Last** (the circular economy strategy).⁶

The 2030 Agenda for Sustainable Development, adopted by all United Nations Member States in 2015, accompanies it blueprint for progress with 17 specific Sustainable Development Goals (SDGs).

Appendix 3 TTF Options Appraisal - Delivery of Activities

This options appraisal is based upon TTF and stakeholder discussions, together with feedback from the community survey. It has been used to build the Activity Plan in section 8 of the business plan and informed the operational financial model.

Summary of options and delivery models considered:

- 1. Promote the Transition Hub space for hire to partners to deliver activities and services—marketing to a wide range of organisations. Serve as Moray's Community Climate Change Hub with job training and education workshops and a demonstration site.
- 2. Create hot desks to hire within the Hub
- 3. Create permanent artist work space to hire within the Hub
- 4. Create permanent office space to hire within the Hub
- 5. Create a café with in the Hub
- 6. Rent outside space to other organisations for project development and delivery
- 7. Purchase containers to hire to organisations for project development on site
- 8. Maintain outside space for a marquee for farmer's markets / craft fairs
- 9. Revisit current rental fees for growing space and overheads (e.g. insurance)
- 10. Expand garden / polytunnel / greenhouse space for hire
- 11. TTF to continue running existing, and develop new, 'inhouse' projects, e.g. Let's Eat, Wellbeing project, Equipment hire business, Repair shop/upcycling, Tool library, Electric bike hire, Community composting scheme
- 12. TTF to develop a programme of free education and community events and activities to increase engagement and deliver TTF outcomes. E.g Transition Towns speakers and events, Practical advice and guidance around reducing personal carbon footprints, community events and open days.

Summary of TTF decisions re delivery

As a priority, TTF will Promote the Transition Hub space for hire to partners to deliver activities and services, marketing it to a wide range of organisations. The community survey has identified a range of people and organisations who are keen to deliver activities from the space and these will be followed up by TTF in the near future.

TTF will also continue running the existing 'inhouse' projects, as funding allows. The Board members leading the Let's Eat and Well-being programmes will continue to work on sourcing funding for ongoing programmes.

New project development will be carried out in partnership with other organisations and led by TTF Board members with volunteer support e.g. Repair shop/upcycling, Tool library, Electric bike hire, Community composting scheme.

Hot desks and office space for hire will not be promoted, although there is flexibility if a suitable partner wishes to rent a small amount of office space and access can be enabled simply.

A permanent café may be possible as part of a supported project.

Permanent artist work space is not possible, although outside space for containers / sheds could be rented to artists/makers.

Outside space will be made available for rent for a variety of uses, including growing, polytunnels, containers and sheds for partners. TTF will plan the space and access requirement, to include space for small farmer's and craft markets, and approach the planning department to establish any planning requirements. Partner organisations will fund any infrastructure in phase 1.

The current rental fees for the Community Garden will be increased to cover a small proportion of the rent increase being paid by TTF.

TTF will not invest in infrastructure (containers, polytunnels etc) in phase 1, as all efforts will be on fundraising re any funds required for purchase and covering current running costs. This will be reviewed from phase 2 onwards.

TTF will work towards delivery of paid for courses and activities and an outreach programme in phase 2.

Appendix 4 – Community Survey Analysis

Methodology

A community survey was undertaken during March and April 2021. It was available online and as paper copies. A postcard was delivered by the Royal Mail Door to Door Service to every household in Forres (8,036 households in IV36) with a QR code and a link to the online survey. Transition Town Forres volunteers distributed postcards in sites in the town centre and the survey was widely promote online, include a Facebook Advertising campaign. A press release was sent to local publications.

The surveys were then collated and analysed using SurveyMonkey. A total of 383 surveys were collected, which is a 5% sample of the households in the area.

The data at the end of this analysis show that all age groups 25 years and older were well represented in the sample. Over 60% were female and 95% lived within 10 miles of Forres town centre.





Summary

The survey was mainly completed by members of the community who were aware of Transition Town Forres and their activities. They showed a high level of support for the TTF aims of promoting sustainable lifestyles and systems to create a more resilient local economy.

One of the main themes that came out of the survey was the support for using the facilities as a community resource. There were a huge range of suggested activities that could take place both indoors and outdoors, covering areas from yoga and drumming to cookery and gardening.

We suggested the main room as an area that could be rented. 190 people were interested in using the space, mainly for one off events and meetings. The majority were willing to pay £10 an hour, some were happy to pay up to £20 per hour. Other charging structures were suggested in the comments, including a daily charge and a percentage charge on the income from any courses that took place.

Other income generating activities included hire of a hot desk or office space; 26 people left contact details to show their interest. Community workshop space hire attracted more interest, with suggestions of between £10 to £60 a month spend. The tool library suggestion was also popular and would work well with a workshop space.

We also asked if people would be interested in running a business, social enterprise or event from the site. 45 people were interested in hiring outdoor space on the site, mentioning craft fairs, farmers markets and events. 35 people were interested in hiring workshop/container/cabin space, mentioning training, repair and maintenance projects.

The community garden was important to the survey respondents, 72% showed an interest in the expansion of facilities in this area. Gardening classes and workshops were also mentioned regularly in the open ended comments sections.

77% of the survey respondents support TTF purchasing the land from Moray Council via Community Asset Transfer (CAT). Only 11% did not support this action, however it should be noted there were several strong comments against the CAT.


Several organisations and many individuals used the open comments section at the end of the questionnaire to off their support for this project. There were some negative comments around the purchase of Common Good Land.




Q4 Do you support TTF applying for a Community Asset Transfer in order to purchase the land that they have been renting from Moray Council at Bogton Road?


Q7 Would you be interested in renting a hot desk or permanent office in the centre?

The most anyone was willing to pay per month was £60. There were several comments of £10 to £25 per month. Several comments said they would rather pay on a one-off or ad-hoc basis.


Q10 Would you be interested in hiring tools for use in your own home from a Tool Library?

5.4 Partnerships

We recognise that we are unable to achieve our aims in isolation so we will work closely with other local organisations that are a part of the solution to lowering our town's carbon footprint and increasing its environmental, social and economic resilience. Some of our local partners include:

1. Moray Waste Busters - A social enterprise with whom we share values of promoting a circular economy. They are dedicated to upcycling, by restoring homewares such as furniture, bicycles and appliances that were otherwise destined to be downcycled into scrap materials, and instead returning them directly back into to the economy with low-cost sales. They also provide work experience for young people in a supportive

- environment. Since 2017, MWB have hosted regular upcycling workshops with the Revamparama project.
- 2. **ReBOOT** A similar social enterprise to MWB, focused on IT/computing hardware. ReBOOT have provided Portable Appliance Testing services to TTF at low cost.
- 3. Moray Carshare (MCS) is a registered charity offering affordable transport while minimising environmental damage, in line with TTF's aims. In March 2018 TTF discussed providing suitable premises for MCS to carry out minor repairs to their fleet and agreed to a 3 month trial using floorspace of the Black shed. In July 2018 we reached an agreement that MCS would rent the shed space one day per month in an exchange for a donation. This will be reviewed in the spring of 2019. MCS seeks to replace its fleet with electric cars, and to introduce electric bike rental points around Moray, presenting an opportunity for TTF to share their electric car charging point with the scheme in future.
- **4. The T-Exchange** are a club registered as a SCIO, who organise activities supporting STEM education and enterprise within Moray and seek to establish a permanent Makerspace to further support these activities. A few of their members have volunteered to help guests at repair café activities.
- 5. Findhorn Bay Arts have held an annual Art Festival and Forres Culture Day for the last few years they have used TTF's hall for some rehearsals and invited the Café Collective team to take part in 2018's Culture Day Event on the high street.
- **6. Glasgow School of Art** have held Masters degree programmes at the Altyre estate south of Forres since 2015, where their Institute for Design Innovation has been actively involved in helping charities to develop their services, and have held community engagement activities, e.g. at TTF's 2018 AGM.
- 7. **tsiMORAY** helps to grow and develop volunteering, community groups, charities, voluntary organisations and social enterprises across Moray.
- 8. Film Forres & TTF Film School Partnership. Film Forres, a community cinema based in Forres Town Hall, is in the process of establishing a Film School. The aim of this project is to build community through the medium of film and digital media. Since community growth and resilience is a major aspect of Transition Town Forres, it is clear that TTF would be an ideal partner. Preliminary discussions with Film Forres and TTF have resulted in broad agreement by the directors of TTF to proceed with this exciting venture. The Film School would be able to make good use of the facilities, skills and knowledge at TTF.
 - There will be opportunities for young people and adults to create video content that promotes local organisations, businesses and social enterprises. Potential for screenings is available at regular intervals at Film Forres in addition to digital platforms and social media. A specific partnership aim is to offer young people the opportunity to create digital content that will raise awareness and challenge current issues around climate change.
- 9. NHS Grampian Let's Eat projects' first four years was fully funded by NHS Grampian and the project has continued to receive invaluable support from the Forres Public Health Coordinator and other team members.
- 10. Moray Food Plus (formerly the Moray Foodbank) The Let's Eat project has received ongoing support in the form of surplus supermarket food deliveries, that have been distributed to groups we have been working with in situations of economic vulnerability.

TTF Volunteer Policy 2021

1. Introduction

Transition Town Forres aims to:

- Offer positive alternatives to the challenges of Peak Oil and Climate change
- Strengthen the local community of Forres and its surrounds
- Promote alternative, healthy food choices for local people

Volunteers make a vital contribution to our aims. We recognise the added value that volunteers bring to our organisation and those who use our services.

Within TTF, volunteers are involved in many ways, including:

- · Board of Directors
- Keeping the centre open
- · Behind the scenes administration, building maintenance and fundraising
- Providing events or programmes as well as support for events and programmes

TTF aims to have a reciprocal and mutually beneficial relationship with our volunteers, with their involvement informing and developing our work. Volunteers may learn skills such as sociability, organic gardening, catering, organisational abilities and achieve personal development through their volunteering.

The involvement of volunteers will be guided by the following principles of good practice:

- the tasks to be performed by volunteers will be clearly defined, so that everyone is sure of their respective roles and responsibilities;
- the organisation will comply with the Data Protection Act in the use of data held on all volunteers;
- all volunteers will be provided with a full induction and training opportunities;
- volunteers will be provided with regular opportunities to share ideas/concerns with an appointed person as part of their 6-monthly support & supervision session;
- all existing and future policies will be checked as to how they affect volunteers.

2. The Purpose of this Policy

By adopting this policy, TTF aims to:

- highlight and acknowledge the value of the contribution made by volunteers;
- reflect the purpose, values, standards and strategies of the organisation in its approach to involving volunteers;
- recognise the respective roles, rights and responsibilities of volunteers;
- confirm this organisation's commitment to involving volunteers in its work;
- establish clear principles for the involvement of volunteers; and
- ensure the ongoing quality of both the volunteering opportunities on offer and the work carried out by our volunteers. This document and the associated policy, procedures and guidance provide a framework for the involvement of volunteers.

3. Recruitment and Selection

Volunteers will be actively recruited from the local community through events, posters, social media and word of mouth. Tasks and roles will be clarified at the outset, so volunteers can see what is required and what skills they may need or can learn. Every effort will be made to match volunteers with suitable roles and all necessary training will be provided.

TTF will adhere to its Equal Opportunities Policy when recruiting and selecting volunteers. All potential volunteers will be asked to complete a volunteer's application. Written task descriptions will outline time, commitment, necessary skills and actual duties. Where there is specific training required, this will be highlighted as part of the recruitment process. Where there is a requirement for a PVG Check known at the time of recruitment, this will be highlighted as part of the recruitment process. All volunteers will be required to provide 2 references. Where individuals cannot be placed, we will endeavour to refer them to another agency who can support them to find a volunteering opportunity.

Support and Supervision

Once placed, we will expect volunteers to comply with existing policies and procedures. All volunteers are covered under Transition Town Forres' Public Liability Insurance.

All volunteers will have an induction to their volunteering which will involve an overview of the relevant policies and procedures, including confidentiality and GDPR. Following Induction, volunteers will have regular support and supervision meetings to identify areas for development, or to discuss any issues. A record of these discussions will be held as part of the individual volunteer's records. Volunteers can have access to their records at any time.

Lone working

If a volunteer is working on the site alone then a staff member, Director or other volunteer must be notified and a mobile phone carried at all times.

Expenses

Volunteers may put in a claim for reasonable expenses, though TTF's ability to pay such claims will be strictly limited by the funding available to cover volunteer expenses. Volunteers shall discuss any planned expenditure prior to incurring these expenses to ensure that they will be covered by the organisation.

Where volunteers have holidays or other commitments which mean that they cannot attend their normal volunteering, they should advise the Volunteer Coordinator to ensure that TTF can arrange alternative cover. If volunteers require a longer break from their volunteering, they should discuss this with the Volunteer Coordinator. TTF will endeavour to accommodate the needs of volunteers.

Volunteers can access learning and development opportunities which are relevant to their volunteering role throughout their time with TTF. Opportunities for Learning and Development will form part of the discussions at support and supervision sessions.

Problem Solving

Where a concern is highlighted – either by a volunteer or about a volunteer - this will be dealt with using the organisation's Disciplinary, Grievance and Dismissal Policy.

Responsibility

Overall responsibility for the implementation, monitoring and review of the policy and procedures lies with Board. Implementation and adherence to this policy is the responsibility of all staff and volunteers within the organisation as well as independent contractors working with TTF.

Across all Board Members and staff there are approximately 48 hrs per week of time available to support TTF.

Summary of TTF Board and Staff Skills

The TTF Board Members and staff completed a skills audit to highlight areas of strength, where skills can be shared, together with gaps that need to be filled.

The collated results above show strong skills in the majority of areas required for TTF activities, including taking ownership of the Centre. In particular, TTF has a high level of skills and knowledge in planning and organising community activities, community engagement, environmental sustainability education, health and well being and food.

The team possess good skills in funding applications, financial management, governance, board responsibilities, staff management, communications health and safety and partnership development. There is an opportunity to share skills across Board members within these areas

Further expertise through recruitment of new Board Members, in addition to potential training for current Board Members and staff in financial management, monitoring of outcomes, marketing and facilities management would be beneficial.

Recruitment of more Board Members to complement skills and add capacity would be desirable in the future.

The TTF Manager role is increased to two days a week initially, 3 days from 2023 and to 4 days per week from April 2024.

Running costs of the site are based on current figures with a 3% annual increment.

The model assumes that the CAT transfer process takes until April 2023 to finalise, so rent payments are included to March 2023.

TTF ownership of the site from April 2023, so no rent or water rates (charitable exemption) from that point.

The cleaning budget includes the cost of a part time cleaner.

Container purchase may be funded by a partner organisation, as TTF may not have the capacity to fundraise for this in addition to site purchase match funding. Income from markets relates to the detailed spreadsheet in appendix 10 – the baseline is highlighted in yellow. 21-22 is 75% of the baseline, then a 10% annual increase in income is assumed from 2023 onwards, as promotion and management of the Hub grows and bookings increase.

A low level of regular TTF fundraising is required to maintain the financial model.

A standard rate of £15 per hour for hire of the Centre is appropriate. We will reserve the option to offer a reduction in price to £12 per hour for regular users (for example book at least 6 sessions) and charities. The financial tables are currently based upon £15 per hour, together with a conservative estimate of weekly bookings. We will monitor this and allow reductions as appropriate, ensuring that running costs are covered.

The addition of a Development manager will allow us to maximise income for outdoor assets such as our electric charging point and the tool hire facility. Assumptions are taken from our community survey, appendix 4, in which out of 377 who answered whether they would join a tool library, 172 said yes. Costs are taken for the suggested annual donations from Edinburgh and Stirling at £30 per year.

The adddition of a Development manager wil allow us to capitalise on our position as an educational hub and resource centre.
