quarter 2 pop-up shops were launched in Buckie with the first businesses having been successfully trading & now seeking permanent basis.

The Scotland Loves Local Moray Gift Card has been launched in November 2021. A total of 179 businesses have registered for the Moray Gift Card Scheme, however 17 were unfortunately unable to participate because they didn't have card readers. There are now 113 businesses live and listed on the website with 49 more to be included when they have completed the card transaction process. Council agreed to provide further dedicated support to the scheme for next financial year.

Through the Town Centre Capital Fund 51 businesses received grants of £1,189,479 for Transforming empty space to living space, Altering large Retail Units into smaller ones & shop front improvements / small grants, which on completion will lead to an investment of £3,838,958. However COVID 19 restrictions and sharp increases in construction cost still presents major problems to complete projects. Still waiting for Scottish Government to confirm extension of deadline.

Business Gateway leads on the provision of post-Brexit and Procurement 1-2-1 consultancy (Part funded by HIE). This is delivered as part of the Moray Recovery Plan and helps mitigate impacts of Brexit and enable SME's in Moray to continue to trade in Europe and/or enter new markets. At the end of Q4 - 16 SME's have received 1-2-1 support over 29 days. Within these stats 3 SME's with high exposure to EU markets and the local supply chain, have been supported with 1-2-1 procurement consultancy over 6 days.

1-2-1 Procurement support has been delivered 6 businesses in Q4 Local public sector contract opportunities remain limited - although Highlands and Islands wide the numbers of opportunities available are significantly higher and Moray businesses are recognising their value. Uptake for this service comes when contract opportunities present themselves.

In Q4 a further 33 new ventures started up with direct interventions from Business Gateway (total of 123 new start form the year – 32 up on 2020-21) with 283 Moray businesses given advice on start-up, diversification and innovation also in Q4.

The Moray Business Start-up Grant was launched on 13 Sept and closed on 31 March 2022. In Q4 a total of 33 applications were

		assessed, verified and approved. 50 grants of £1500 have now been assessed, verified and approved to year ended 31 March 22 when the grant scheme closed as funds totalling £75K were fully committed.
