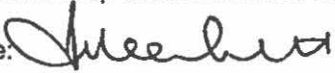

THE TOWN AND COUNTRY PLANNING (SCOTLAND) ACT 1997 AND THE ACQUISITION OF LAND (AUTHORISATION PROCEDURE) SCOTLAND ACT 1947

Moray Council, incorporated under the Local Government etc. (Scotland) Act 1994 and having its principal office at Council Office, High Street, Elgin, IV30 1BX (hereinafter referred to as "the Acquiring Authority") in exercise of the powers conferred by section 189 of the Town and Country Planning (Scotland) Act hereby makes the following compulsory purchase order-

1. This Order may be cited as the Moray Council (Lossiemouth to East Beach Replacement Footbridge) Compulsory Purchase Order 2022.
2. Subject to the provisions of this Order, the Acquiring Authority are hereby authorised to purchase compulsorily for the purpose of securing the redevelopment and improvement, as is necessary in the interests of the proper planning of the area, the land which is described in the Schedule hereto and is delineated in red and coloured pink on the map signed with reference to this Order and marked "Map referred to in the Moray Council (Lossiemouth to East Beach Replacement Footbridge) Compulsory Purchase Order 2022".

The subjects form part and portion of the lands described in the Disposition by Francis John Tennant to Innes Estates recorded 10 April 1931.	No conclusively identified owner – the Innes Estate company no longer exists and title may have subsequently been transferred to one of the following: (Sir) Iain Mark Tennant (now deceased); (Sir) Iain Mark Tennant's Trustees (now dissolved); Mark Edward Tennant; Edward Iain Tennant; and The Trustees of the Innes Estate Trust (now dissolved).	Unoccupied

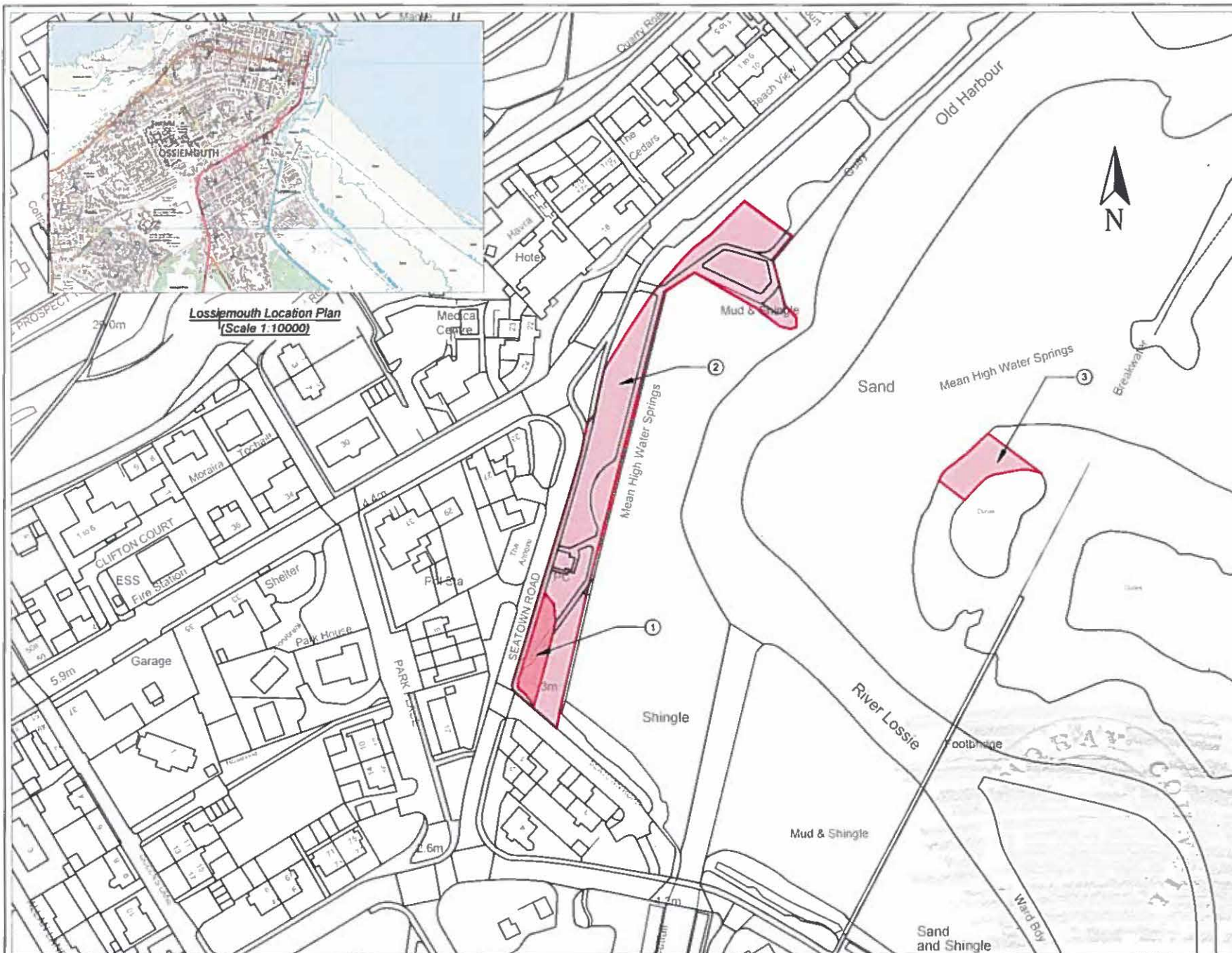
