Introduction

The Small Business Bonus Scheme reduces the amount of rates payable by small businesses. It can only be awarded to properties which are actively occupied.

This application form is for ratepayers who occupy MULTIPLE properties.

Qualification

An award of Small Business Bonus Scheme relief may be made if the following conditions are met:

- the property for which relief is sought is occupied
- the rateable value of an individual property does not exceed £20,000
- the combined rateable value of all your business premises for which you pay rates whether occupied or unoccupied does not exceed £35,000
- the ratepayer occupies multiple non-domestic properties in Scotland

The following types of property are excluded from receiving this relief:

- · properties which are unoccupied
- properties which are principally used to display advertising
- · properties which are principally used to facilitate betting
- properties which principally comprise one or more parking spaces
- properties which principally are used to facilitate payday lending

This table shows the value of relief a ratepayer occupying MULTIPLE PROPERTIES may receive

Combined rateable value (RV) of all non-domestic properties in Scotland	Percentage of relief available
Up to £12,000	100%
£12,001 to £35,000	25% on each individual property with a rateable value up to £15,000
	For individual properties with rateable values of £15,001 to £20,000, relief tapers from 25% to 0%. Relief amount is determined by the following formula: 25x((20000-RV*)/5000)

Note – RV* is the 2023 rateable value of your property on the date on which you make an application for Small Business Bonus Scheme relief.
