The Council is now seeking external expertise to conduct a comprehensive Leisure Assets Review. The intent is to establish a robust evidence base to guide their strategic planning, investment decisions, and management practices concerning leisure assets.

The review will encompass several crucial areas, including but not limited to: inventory and condition assessment, usage and demand analysis, financial performance, socioeconomic and environmental impacts, user satisfaction and needs, benchmarking against similar provision elsewhere, asset accessibility, gap analysis, technological opportunities, and strategic prioritisation.

The Council have invited consultants to approach this review with a spirit of innovation, embracing new ideas, and emerging trends in leisure asset management. The insights and recommendations generated through the project will be instrumental in shaping the future direction of leisure asset provision in Moray, aligning with Council broader goals of health, well-being, social inclusion, and environmental sustainability.

- Exploration of wider opportunities to optimise the use of other parts of the public estate to meet service needs and align with Moray Council's wider corporate priorities. This may involve co-location with other services and facilities.
- Analysis of other relevant leisure facilities provided by private entities, third parties, or others.

Upon completion of the review, we will deliver:

Recommendations for the future use of leisure facilities and wider property assets.
These recommendations will be geared towards meeting future service needs and supporting wider corporate priorities.
