#### **Blackhills Windfarm Presentation**

A presentation on the proposed windfarm and battery storage development was delivered by representatives of Koehler, the developer, Green Cat Renewables, renewable energy consultants and Orbit Communications.

This presentation followed on from the second round of exhibitions held by the developer.

The presentation was followed by a Q and A session.

A planning application will be lodged with the ECU in May 2025

MR gave a vote of thanks to the presenters before proceeding to the remaining items of business.
