DEFCO Pipeline Update: Meeting has been offered on July 17th at 7pm in the Grigor and Young Offices, however there was mixed opinion as to wether we shoulf accept this as we feel they are hiding something from us as they are refusing to allow us to bring anyone other than ourselves. Further discussion was had about wether we should insist on bringing Environmental Health Officers with us, this was agreed to be put to the lawyers that we accept the meeting and would be bringning an Environmental Health Officer with us, JC to draft a letter to accept.

4. Fishermen's Shelter - Chris Tuke

Chris addressed the meeting to give some history on how it was set up and what has happened since including the removal of the funds to a seperate account to protect it from getting taken by the Council. He asked if the CC would be willing to take the funds under our control and look after it and protect it through being part of proper accounting and minuted meetings. It was agreed that should the CC fold every effort should be made to appropriate the funds somewhere else within the community and it should not revery back to council accounts. Everyone present agreed that it could move back to within the CC control, JC confirmed he is happy to be the link to the Fishermans Shelter.

10. AOCB

RM raised the issue of the filming at the harbour, that they have lost a vast space due to the filming yet fisherman are expected to pay the same dues etc. Whilst we support this in principle, there should be a financial contribution be made.

JB added that the inflatable gentlemen came to the community gardens to ask if he could use the community gardens, this was with one days notice and upon further inspection it was clear the garden public liability insurance would not have covered what is required by the gentlemans own insurance. It was unfortunate to see that the gentleman had posten publicly about the cacellation of the event and seemed to lay blame on the gardens which was not the case. JB also mentioned that the gardens got some money from Just Transition and someone is producing a publication to show what they bought, the wild flower area is also stunning at the moment.

Cllr Cowe asked for all details relating to the Church of Scotland to be sent to the councillors. MK raised that a Cummingston resident asked wether the toilets at the park are open and if they are who is maintaining them, JP confirmed this was the council and is done at certain times of the year. MK also added that is there signage that could be placed there to point people to the Burghead Chemical disposal area.

JP went through some explanations of the type of gas (H2S) that is emitted from the pipeline and the potential impacts to health, with numerous possible problems it is clear this is very serious.

There being no other business, the Chair declared the meeting to be closed.
