# 3. Matters Arising from minutes

DEFCO Pipeline Update: Donna from Grigor and Young was present to update the meeting on the work that had been done since members of the CC, the community and two of our local councillors (Cllr Cowe and Cllr Cameron) met with her at her office in Elgin in July. Donna updated the meeting on the huge amount of work that has been done since this meeting to address the issue with the odour in Burghead. Though much was confidential, all were pleased to hear just how committed Donna's clients have been in order to address the issues raised by the community and appreciate the effort that has been taken.

# 4. Public Meeting War Memorials Update

JC drafted a letter on behalf of the CC to the Church of Scotland regarding the unacceptable delay of the removal of the War Memorials from the Church. CCs were advised to follow this up strongly through all official channels and not to let this go, also to look into the movement of the around £400,000 taken which was left to the people of the Church of Scotland Burghead and may have been left in trust. It was agreed that all avenues had been exhausted and to proceed with a press release.

There is also a new Harbours Manager which is hoped will see a positive communication between them and us.
