The University of the Highlands and Islands were working with Boeing on a proposal regarding an aerospace and advanced technology campus. In early 2024 UHI informed the Growth Deal Programme Board that this project would not be proceeding.

Boeing also sit on the EY STEM project board, detailed in the answer to question 7.

There are no other projects that Boeing either had or currently have an involvement in.

2. If The Boeing Company are involved with the Moray Growth Deal, what division(s) of The Boeing Company do employees represent?

The representative of Boeing who sits on the EY STEM Project Board is from their Commercial Training Campus in Crawley.

Former aerospace and advanced technology campus project: The relationship with Boeing was managed by the University of Highlands and Islands and as a result they are the partner who can confirm Boeing's participation in project boards / project meetings.
