 - * Some of the current zones are very large and this is causing many of the routes to be inefficient. Further work to be undertaken on this issue.
 - * 691 Speyside on demand service changes are likely to be made but it is vitally important that rural communities are not disadvantaged.
 - * There is a possibility of matching fixed route services (ie timetabled) to on-demand services (ie connecting).

Teindland Windfarm.

12 turbines plus battery storage

There have been a number of issues surrounding the consultation from the Energy Consents Unit/Applicant.

Speyside Community Council has been given an extension to 30 November, 2025.

Blackhills Windfarm

6 Turbines plus battery storage.

This proposal is adjacent to Teindland Windfarm and while there are two different developers it will, in effect, look like one windfarm.

MR has applied for an extension to the consultation period but is waiting for a reply from the ECU.

Business: Joint Community Council

*The National Strategy for 20mph in Moray

This will only affect roads with a current limit of 30mph, with premises fronting the road over a 400m to 600m length and proximity to places of worship, schools, medical facilities etc. Public information, including maps and a 'have your say button' will be on the 'Moray Engage' website. Transport Scotland have given the funding for this work (including the signage).

Temporary traffic regulations will be drawn up and the 20mph limit will be trialled on the selected roads. Changes can be made during the first 18 months of operation. The 20mph limit will be withdrawn if it is not working.

This will not affect the Trunk Roads with a current 60mph limit.

*Consultation times for major planning applications

SCC has requested that the Chair of the JCC write to John Swinney and other appropriate MSPs requesting that that the consultation period for major planning applications should be extended, as the current timescales are impossible to meet.

Finderne CC also requested that there should be no consultation requests on planning matters etc during CC election periods.

- *Review of Scheme for the Establishment of Community Councils This was adopted by Moray Council's Corporate Committee on 26/8/25.
- *<u>Timetable for Community Council Elections</u>

 The timetable was outlined together with information regarding completion of the nomination form.

The new term for uncontested CCs starts on 27the October 2025.

*Moray Council's proposed policy for overnight stays for campervans
Cllr Gordon requested that this item was included in the Agenda.
After a lengthy discussion, the conclusion of the meeting was that
this policy would likely create a problem where none currently
exists. Therefore, the meeting could see no requirement for a policy
that can't be enforced.

AOCB: MM provided an update on the aspirational plans for Fiddich Park, Craigellachie. These would include a visitor centre with toilets and an interactive learning environment for schools. This would be situated on the old platform.
