Item 1 - Welcome

- a. Apologies D Anderson, S Dominey, A Hart, Cllr P McBain, Cllr D Van der Horn
- b. Declaration of Interest to be raised as and when it occurs.

Item 2 – Public Session

- a. Community Safety Report/Police Scotland Report There has been no new quarterly Police report received.
- b. Any other competent public business / public correspondence also to be raised through agenda items.
 - i) A Skene provided an update on the enquiry submitted to Moray Council regarding the motorhome site at the Captain's Table boatyard. The response from the condition compliance officer stated that the site has been classed as a Certified Aire Site under the auspices of the CAMpRA Rally Group allowing for a maximum of five motorcaravan pitches for year-round use. The FKCC will seek further information about spacing, length of stay and outlets for chemical waste.

<u>Item 3 – Ratification of Minutes of Meeting from Thursday 25th August 2025, at Osprey Room, JMI, Findhorn</u> **3.1** The minutes of the meeting of Thursday 25th August were agreed to be accurate, proposed by A Shepherd and seconded by R Hutchinson.

Item 4 - Matters Arising

- **4.1 (4.1) (4.1) (4.1) (4.1) (4.1) (9.1) (4.1)** A Shepherd reported that she had been investigating additional funding and preparing proposals for replacement play equipment at Southside, Kinloss. She had investigated the Scottish Landfill Communities Fund but found that it involved a lot of work and grants had already been awarded to the local area. EB Scotland applications have a lighter touch and A Shepherd will pursue when applications open in October, and also look at Awards for All. A Shepherd reported that she would be meeting with a playground supplier to look at designs and equipment. Cllr Robertson advised asking for support from Moray Council. **ACTION: A Shepherd to contact L Cameron, the Moray Council Support Unit Officer, to request help in the application process.**
- **4.2 (4.3) (13.3)** R Hutchinson confirmed work on the list of items and their value to enable the add-on to the community council insurance to cover the resilience equipment is on-going. **ACTION:** R **Hutchinson to compile list of equipment in consultation with M La Tourelle. COMPLETED**
- **13.2 ACTION:** R Hutchison to supply full details of costs for Fire warning signage. COMPLETED. (The FKCC and FVCC each paid 50% of the costs.)

Discussion followed about the location and positioning of fire warning signs in both Findhorn and Kinloss. It was agreed that a clear protocol was needed for the erection and duration of signposting, for example, High Risk/Extreme Risk.

Item 5 The Findhorn Village Conservation Company

- **5.1** The FVCC now own the two telephone boxes in Findhorn and will consult the community on preferred use. A popular idea is to have them accommodate defibrillators. It has also been proposed to have a defibrillator at the north toilet block, close to the beach. It was suggested that there should be signage indicating where the defibrillators are situated around the village. Kieran's Legacy will be consulted.
- **5.2** The FVCC offer to buy Findhorn church from the Church of Scotland has been accepted in principle and part funding has been secured. The working group aspire to employ a project officer/coordinator to work on the project and business plan.

Item 6 Kinloss Barracks Report

- **6.1** S Kane reported that there will be a regimental exercise from 6-16 October which will see increased activity on the base.
- **6.2** On 2nd November Condor Motor Sports will be holding a car rally on the base. Neighbours have been notified.
- **6.3** A change of provider for the nursery is ongoing and progressing. It is hoped that the facility might include wraparound care.
- **6.4** S Kane was asked if there was fire equipment on the base which could assist in local emergency situations. Now that the runway is inactive, there are no emergency fire vehicles on the base.

Item 7 Chair's Report

7.1 There is no separate report other than items covered in the agenda.

Item 8 Secretary's Report/Correspondence

8.1 A request for funds has been received from the Kinloss Gardening Club to enable them to improve the half barrel planters in front of the Spar shop and Primary School entrance. The club has 10-12 enthusiastic members and a children's gardening club has now been formed. Several garden initiatives have already been undertaken. It was agreed to give the Gardening Club the requested funding.

Item 11 Moray Councilors' Report

11.1 Cllr Robertson reported that she had attended the recent Forres Academy Parent Council meeting and learned that the ban on mobile phones was working well. There is an all-day restriction for both staff and pupils.

The planning application for the new Forres Academy has been lodged. Public comments can be submitted through the normal planning channels. A new postcode will be needed for the new school as technically there is closure of the old school and a new school is being built. Consequently, a relocation consultation is taking place and parents are being asked to contribute to the consultation by agreeing to the move of location.

Moray Council received a positive external audit report for 2024/25 confirming improvements in governance and performance management.

Cllr Robertson thanked the FKCC members for their work and commitment over the last CC term.

13.1 R Hutchinson reported that it was time to move into phase 2 of resilience planning and that there would be a change of direction at meetings. They would become more practical and workshop based, to look at protocols and equipment use. Over the last 2 years, the resilience planning group has developed successfully and become well established. Now is the time to move towards action and consolidation. He added that the group are aware of the approach of the winter season and possibilities of storms when support in the community may be needed.

14.1 S Worth reported that he had contacted all stakeholders and had received feedback from most. The Piper had been contacted and wreaths had been purchased. The Kinloss minister will be in attendance at the Findhorn War Memorial for the Remembrance Ceremony at 9.45am and the religious service will be held at Kinloss Church at 10.15am. The Remembrance Ceremony at Kinloss Abbey will be at 9.15am.
