I have many concerns, but the stand out is linked to Applegrove primary school children, their greenspace, their playground and their mental wellbeing. Removal of Applegrove playing fields- Please don't take this decision lightly. The playing field is well used and loved by kids at Applegrove and is an asset to the school in terms of greenspace and wellbeing. The kids play in this area every break and lunch, they play sports such as football daily, they use this space for PE, for the Monday run club, for their sports days, for outdoor learning, for the daily mile walk, for Applegrove football team training, just to name a few. Where will they play when this turns into a construction site? Where will they do sports day? There is no clear proposal to replace this primary school greenspace and play area. ( sharing a small bit of left over common good land with a secondary school does not suffice ) this area does not belong to the school and is not contained like the playground is. I find it unbelievable that you would even consider taking away green space ! This is a travesty. There is mounting evidence that nature and greenspace has a positive effect on mental health, Yet I just don't think that the cost of removing this open green play space has been fully appreciated and considered. Studies have shown that green spaces can lower levels

of stress (Wells et al, 2003) and even reduce rates of depression and anxiety and improve general wellbeing (Park et al 2010). Why has there not been more debate around what the primary school children are losing by choosing this site? Why even consider taking this away when there is a perfectly good alternative greenfield site as an option? Removal of community Greenspace /CGL It speaks for itself, why would we remove greenspace which the community enjoys in the middle of a town? This space is hugely important to the community and it feels that this has been underestimated. (think of the positive benefits this space has on community wellbeing and the environmental impact with its removal.) Will the trees be cut down? The list of concerns goes on..... Construction site within playground and neighbouring space of Applegrove - concern about the impact this will have on the primary aged children at Applegrove. Traffic: this will create MAJOR issues. Already the roads surrounding Applegrove and Roysvale are extremely busy, often gridlock . I speak for experience of dropping off and collecting children Monday -Friday. Always many cars illegally parked. Noise pollution within a Primary school playground whilst kids are trying to learn? The design with 3/4 stories very much gives the feeling that you are trying to shoe horn a building into a compromised small space. Please reconsider, build onsite at current academy site or share why lochyhill was dropped as an option.

Replacing the existing accessible outdoor learning space with an ecological garden, amphitheatre and outdoor classroom space which is much smaller than the space now will not enhance outdoor learning as it will not be large enough. There will not be enough time to access the green spaces currently used as it would take too long to get there and back. The size of the outdoor space for potential teaching would be limited to one or two classes at a time where as currently the green areas can accommodate many more pupils outside. 'The new design will facilitate high levels of collaborative and collegiate working among educational professionals'. This is actually insulting! 'The new building will be designed to promote accessible and inclusive learning, meeting the needs of all learning including those with enhanced Additional Support Needs who will be accommodated in well considered accessible facilities that will support them from their arrival on site, throughout the day, through formal learning and informal social times. Internal spaces will be further complemented by accessible outdoor spaces, enriching the learning environment and skills development for young people further.' The area dedicated to ASN in the new build is actually far smaller than the space we already have. Therefore, the new building design actually does not meet the needs of pupils with ASN! The new building will also provide an improved wireless-enabled learning environment to maximise the effective use of digital devices and promote digital literacy and independent learning. Flexible partitions sound cumbersome, not sound-proof and also relatively fragile. The adjacency of the new secondary school and existing primary school will support a shared campus approach that will support this more collaborative approach between teachers, subjects and departments, Again, this is just so insulting. To suggest that we don't collaborate and then to suggest that the reason is the building!!!! In summary, I strongly believe that trying to cram a secondary school onto the Applegrove playing field is a dreadful idea. It just isn't big enough. Look at the other new schools in Moray – they take up a much larger area and some have far fewer pupils.

The proposed design squeezes the new building into the Applegrove School playing area leaving no room for expansion. The criteria used to select Applegrove over Lochyhill was largely subjective: with a few tweaks, Lochyhill could have scored more highly. That site would have allowed ample space for expansion. The new building will dominate an area which consists largely of one and two storey residential buildings. It will look out of place and ruin one of the nicest areas in the town. Arguments put forward that the existing school site



could not be redeveloped due to flood risk are nonsense.

Construction of the Chapelton Dam system has virtually eliminated any risk from the Mosset Burn flooding thus the existing site plus the Plasman Field would provide more than sufficient land area for the new academy. I believe that to relocate Forres Academy from its present location and move it to the playing fields of Applegrove Primary School will exacerbate problems already present in this area. The narrow roads in this region serve three schools, a funeral director, a garage and is a densely populated residential area currently just coping with the traffic congestion and hazards. The split site design of this proposal is going to cause parking issues as those unwilling to walk from the designated car park through Roysvale Park to the new academy will park on the narrow roads. The proposed new academy site is at the lowest point of the town. Homes and businesses already flood in this area due to surface water descending from the higher levels. Erecting such a large structure on this playing field which serves as a valuable soakaway will increase the risk of flooding to these homes and businesses. Indeed, Scottish Water in recognition of the risk to these properties have recently issued flood doors. I am concerned that in the future the new academy if built on this site will also be at risk of flooding. By moving the academy forward from its existing site into Applegrove playing fields it will be located in an area surrounded by residential properties in very close proximity. The residents will be in the vortex of activities associated with the new school which is also intended to be a Community Hub. Noise associated with supply vans, traffic and young people moving around the area will affect the residents in particular the Veterans whose homes are immediately adjacent. The business of the well- respected Funeral Director directly opposite the new academy site is likely to be affected. The bereaved attending his premises will be subject to noise during construction. It will be very difficult for him to conduct services in his Chapel. Post construction his Funeral Cortege will still have to navigate the movement of traffic and people attending the new School Community Hub. The highest point of this new academy/community hub is 16 .875 metres. This will cast a considerable shadow in the direction of the Veteran's cottages and the homes Opposite on Orchard Road. Indeed, Applegrove Primary School will be in shadow. Regardless of attenuation tanks installed if the flow is restricted and gravity led to the Mosset Burn then that will surely restrict storage within the tanks. With the best will and design there will be a considerable amount of water redirected from this area to the Mosset Burn. The function of the Roysvale Park and Applegrove Playing Fields as soakaway will be compromised by the large new academy/hub structure and the bus lane and new path from the car park to the new school. There remains a significant adverse risk to this area of flooding!! Roysvale Park is Common Good Land and well used and Applegrove Playing fields is also well used by the primary school children and out of school hours by the public. This green outdoor space will be considerably reduced and the remainder absorbed into serving not only one but the needs of two schools. Therefore, the recognition of each school having to plan for it's use will undoubtedly reduce the flexibility of options for outdoor

Summary I am against this relocation. I don't believe is it good for the Academy, Applegrove Primary or the Community of Forres. General Comments • It results in a loss of Green Space / Common Good Land for the community. • The playing fields of Applegrove Primary will be removed, without adequate replacement. • Neither Forres Academy or Applegrove will end up with their own independent playing fields as they do now. It will be shared space for c.1600 pupils, which is totally inadequate. • Under the 1967 Regulations, the playing fields allocated are short of the legal requirement. • The proposed use of Roysvale as playing fields for primary age pupils does not represent a safe play space, bounded on 2 sides by roads and not fenced off. • Further green space is lost to an unneeded bus lane, claimed to be required as it's not safe for children to cross a road. The same road that will need to be crossed to access the 3G pitches! • The general public is to retain access to Roysale, including for one of the primary purposed which is dog walking. It is a health hazard to have dog poo on playing fields. • The new Academy is clearly too big a building squashed into too small a space. The artist

impressions are cleverly structured to give the impression of space that simply does not exist at the site. • Pupils at both the Academy and Applegrove Primary are being shortchanged by building on Applegrove. The new school will be overlooked by surrounding properties, and vice versa, which is totally inappropriate. • The active spaces around the edge of the proposed Academy are too small to be of any value to a school of c.1000 pupils. They space is no more than that of a corridor around the building. • A new school should capitalise on opportunity, not short change the community over costs. Costs which spread over the life time of a build become minimal. • The consultations papers cleverly refer to the current 2miles radius to qualify for a school bus. It is well documented that this is likely to change to 3, to reduce Council costs. This will put more cars on the road in already congested streets at peak school times. • Teachers will not want to walk from the proposed car park which, is located away from the school building, particularly in bad weather. • The flexible spaces proposed in this build are not likely to be attractive to teachers who will be used to having assigned classrooms / space. • Parking spaces located in the bus lane will inevitably result in cars being parked there when bus access is required. • The proposed building is completely out of keeping with the surroundings of the area. • Forres needs a new academy, not a community facility. • Placing a community facility at Applegrove will likely result in the loss of facilities and economic decline on Forres High Street. Any community facilities moved to the Academy site will not be available to the community with the same flexibility and open access as they are now. That is a loss to the town, not a gain. • Forres community has already spoken out loudly against word of closure of its well-used community centre on the High Street. Forres does not want a community building, it wants a new academy. • I have not seen evidence that drainage / flooding issues have been adequately managed such that this relation will not potentially result in flooding in other areas of Forres. Water will enter the system below the control of the very effective flood alleviation scheme. Impact on Applegrove Primary • Applegrove Primary is set to lose its green space and playing fields. This space is used daily by the children and is a valued asset of the primary school – it is why many parents have chosen the school for their children. • There are no replacement playing fields for Applegrove maintaining the overall playing capacity that the primary children can use at break and lunch as they do now. Roysvale will only be of use to Applegrove primary for supervised PE lessons, and even then, see my other comments regarding the dangers of the site. • The 3G pitch is not conveniently located as required - it is too far away to be practical for primary children and would require numerous staff to be able to walk the children to use it. What use will the primary school ever get of the 3G pitch when competing with an academy with 1180 pupils? • The all-weather pitches are not in “close proximity” for the primary school as required by the 1967 Regulations. •

Applegrove's Playing Fields are proposed to be removed at a time when all recent education reports are focusing on the importance of outdoor space for learning. These reports are entirely in line with the Scottish Curriculum's direction of travel to outdoor learning. The plans of TMC with this build, however, are out of synch. • Applegrove Playing Fields are categorised as ENV4. EP5 Open Space states that proposals which would result in a change of use on an ENV4 Sports Area to any other use will be refused. • The Scottish Government is to reopen consultation on updating the 1967 Regulations before the end of the year, as has been confirmed in writing by Jenny Gilruth. Given the direction of travel with outdoor learning, it is perfectly foreseeable that approving this planning proposal could result in a primary school no longer meeting revised outdoor space requirements under updated legislation. • Forres has a wonderful rural setting (whether or not considered a rural school) and we should be proud to be able to provide more space than the minimum. • All children need space to run around and let off steam, whether they have additional support needs or not (40-50% of Applegrove children having an ASN need). Condensing those c.300 children into a space a fraction of the size previously available will inevitably lead to issues, as frustration amongst the pupils grows. Applegrove primary is stated within the planning documents to have capacity for 460 pupils. If the school was to reach capacity, these issues would only be exacerbated. • Despite mitigations (all of which are totally inadequate), the education of all children at Applegrove will be negatively impacted during construction due to noise, pollution, vibrations, limitations on play space and construction dangers. Alternative Site There is widespread public support for rebuilding on the existing site. Two local architects have submitted plans for such a rebuild and the push backs in the documentation provided in the consultation pack don't seem to account for the alleviation scheme. Lochyhill could also be brought back online as an alternative site and would provide a much better space for a new Academy, with facilities included in a more conventional campus site.
