

## **DYKE LANDWARD COMMUNITY COUNCIL**

Minutes of meeting held on Tuesday 17th June, Dyke Village Hall.

**Present** Mr. D. McConnell, Mrs. M. Greenaway, Mr. J. Rodgers, Mr. C. Hamilton, Mrs L. Dingwall (secretary to the CC) Cllr. I. Ogilvie.

The minutes of the previous meeting were approved by Mr Rodgers, seconded by the Chairman and signed by the Chairman.

### **1. Junior Representative.**

**2. A96 Brodie Speed Restriction.** Awaiting response to letter requesting detailed information regarding criteria for reducing speed limit.

**3. Flood Alleviation Scheme.** Secretary informed the meeting that a response had been received regarding the haul road and landscaping. A meeting was due on 18th June. There are concerns that the haul road could become part of a Core Path.

**4. Fallen Tree.** Cllr. Ogilvie has written a final letter to Mr. G. Elder. Moray Council are reluctant to remove the tree and bill Mr. Elder.

**5. Longley Safety Barrier.** Chairman is in discussion with Mr. Newlands, Bear Scotland, regarding planting to soften the effects of the barrier. Concern was expressed over the time taken to resolve this item. It is possible that some landscaping may be forthcoming for this location.

**6. Brodie Caravan Park.** Secretary has written to Mr. Jamieson expressing CC concerns, awaiting a response.

**7. Potholes in the Dyke Landward Area.** Cllr. Ogilvie informed the meeting that The Moray Council are awaiting a new funding situation, there is a four year financial plan. Response due at the end of June 2008.

**8. Attendance of Police at CC meetings.** Secretary to notify Sgt. Scott of dates of future meetings and ask which meeting he will be able to attend. Specify discussion on Brodie Speed Limit.

**9. Removal of Pay Phones.** There are concerns re the removal of pay phones in the Conicavel and Whitemire areas. Chairman is dealing with this.

**10 CC Treasurer.** Mrs. Greenaway is taking on duties of treasurer to the CC.

**11 Change of Chairman.** Mr. J. Rodgers will assume duties at the August meeting.

**12 Representatives from Dyke and Conicavel.** Cllr. Ogilvie to approach a person from Dyke who may be interested in joining the CC.
