Our Structure

Grampian SCG

"The SCG is intended as a key element of the Scottish multi-level planning and response framework. It also reflects a key principle of UK civil protection arrangements that the initial response to most emergencies is delivered at the local level."

Scotland has eight Policing areas, each area has a multi-agency Strategic Coordinating Group (SCG). SCG's have two functions:

Emergency Response & Recovery

In response to an emergency, the SCG provides both strategic and tactical leadership and coordinates all elements of the North East of Scotland's response to, and recovery from, an emergency. Additional specialist advisors may also assist the SCG in an emergency.

Preparing for Emergencies

The SCG's routine task is to prepare for potential emergencies by conducting risk assessments, preparing plans and exercising

Grampian SCG Working Group

This Group consists of the emergency planning specialists from all the SCG member organisations. It meets every three months to carry out the policies and strategies of the SCG, and to drive the emergency planning cycle illustrated on page 11.



Grampian SCG - Membership

The SCG consists of the Chief Officers and other senior management representatives of all Grampian's public service organisations. Each SCG member attending the SCG has the ability to commit the assets of their entire organisation. Members are listed on page 15.



SCG Liaison Groups

The SCG Working Group has identified the main potential hazards in the North East of Scotland. Each of these potential hazards focuses on a particular site or type of emergency identified during the risk assessment process. A Liaison Group is formed to conduct detailed risk assessments and form emergency plans for each of these identified hazards.






Scottish Government

At national level, Scottish Resilience coordinates civil contingencies matters for Scottish Government.

Scottish Resilience includes the Scottish Fire Services College, the Fire and Rescue Advisory Unit and the Civil Contingencies Unit, which manages Scotland's preparation for emergencies on a daily basis. In response to an emergency, members of the Civil Contingencies Unit manage and staff the Scottish Government Resilience Room (SGoRR), which coordinates the Scottish Government's response to an emergency.



NATIONAL RISKS – LOCAL RISKS – FURTHER INFORMATION

National Risks: The UK Government's aim is to reduce the risk from emergencies so that people can go about their daily business freely and with confidence. The UK Government published the first National Risk Register and National Security Strategy in August 2008. They identified: **terrorism**, **severe weather** and a **flu pandemic** as the UK's highest risks.

Local Plans: Grampian SCG maintains emergency plans based on risk assessments carried out across the area. Each plan is supported by a multi-agency Liaison Group whose purpose is to; review the risk assessment, maintain the plan and exercise the plan. The plans / Liaison Groups, are listed below.


