The Education (Additional Support for Learning) (Scotland) Act 2004 introduced a new framework for providing support for children and young people who have additional support needs. The definition of additional support needs now includes a much wider group of children and young people than the previous legislation.

The 2004 Act recognises that children and young people have additional support needs if they need extra support (including support from partner agencies) to benefit from school education at any time, for any reason. The 2009 Act has further widened the definition of additional support needs by providing that support can come from services other than Education. This support is intended to enable the child or young person to benefit from education.

The term, additional support needs, applies to children and young people who, for whatever reason, require additional support, long or short term, in order to help them make the most of their school education. These needs can last for a short or long period of time and can be required for a variety of reasons.

For example, a child or young person may have additional support needs arising from:

- sensory impairment
- physical disability
- being more able
- behavioural difficulties

bullying

- moving house frequently
- bereavement
- problems at home
- being in care
- communication problems
- frequent absences
- being a young carer
- having English as an additional language

In addition under the provisions of the 2009 Act, all looked after children and young people are automatically considered to have additional support needs unless the education authority determines that they do not require additional support in order to benefit from school education.



In a school, all staff will know their pupils and will be alert to any changes in a pupil's demeanour or approach to work. For some children there are formal routes to recognising needs e.g. Children's Panel and medical services. All schools will have systems in place for raising concerns and identifying need and for communicating information to other staff in the school. Parents may also ask for an assessment to establish whether their daughter or son has additional support needs. This can be done by contacting the school in the first instance.

The above are only some of the reasons for additional support. There are many others and it is important to note that the level of additional support required will vary for each individual child or young person. Some children have greater resilience than others and the levels of need can vary according to the level of support available

in the family circle. The support available can also come from other services such as health, social work and the voluntary sector – all of whom will work together to ensure effective planning to meet the child or young person's need.

As the causes are varied so too are the types of support which can be arranged:

- support to attend school
- support from a therapist
- differentiated class or homework
- pastoral care
- time out in a different part of the school
- specialised equipment
- designated buddy or friend in the school to look out for your child
- appropriate support for assessments
- simply tolerance, awareness and understanding of a situation

For a very small number of children a Co-ordinated Support Plan will be required. This is a plan drawn up by the parents, pupil and all services providing support to enable the child or young person to benefit from education. The purpose of the plan is to ensure that, whenever services are required to work together to enable the pupil to benefit from education, the work is properly co-ordinated and recorded.
