IMPORTANT INFORMATION

Discretionary Housing Payments are payments that the Council may be able to make to help you pay your housing costs, when Housing Benefit does not meet all of your needs. Housing costs may include:

- · rent liability
- · rent in advance
- deposits
- · other costs associated with a housing need such as removal costs.

To qualify for Discretionary Housing Payments you must:

- · qualify for some Housing Benefit, and
- · need extra help to pay your rent or a housing cost.

If you receive a Discretionary Housing Payment, it will be paid along with your Housing Benefit, either to you or your landlord.

Discretionary Housing Payments **cannot** be paid for Council Tax or for service charges included in your rent which are not eligible to be covered by Housing Benefit. There is no list covering every situation that will be allowed a Discretionary Housing Payment. Each case will be decided on its own merits.

The Discretionary Housing Payment scheme is discretionary and a customer does not have a statutory right to receive an award. It is not a payment of Housing Benefit

If you are experiencing **severe hardship** or have **exceptional circumstances** and wish to be considered for Discretionary Housing Payments, please provide details of your circumstances. We may have to ask you for additional information or to provide supporting evidence before we can make a decision on your entitlement.
