Guest Speaker-Recycling:

Duncan Falconer gave a presentation demonstrating the new recycling bins. Some of our rural areas already have these but rolling out to the rest of Moray on the week commencing the 25th of March. There was a lot of discussion about what can now go in the bins, leaflets will be provided with the bins. Concerns were noted from those who are already using the bins in rural areas- no way of securing lids and easily blown over in high winds.

1.Police Matters:

Members made aware of new non-emergency phone number: 101

Since February there have been 39 recorded crimes in Keith. 5 were outside the town itself. One was a theft of plant pots, two were Road Traffic Offences and the remainder were miscellaneous. These mostly consisted of traffic offences, vandalisms, public disorder offences and dishonesty crimes. In response to claims of antisocial driving-operation kingdom-was run on 8-9 February 2013 specifically to target vehicles driving in careless/antisocial manner. A number of offenders have been charged and warnings have been issued.
