4. Scotland Police Report

Between 19 and 30 August 2013, a metal gate was stolen at Mundole Farm, enquiry is ongoing into this matter.

On 29 August a quantity of drugs were seized at Mundole. A report has been submitted to the Procurator Fiscal regarding this. On 4 September 2013, an assault occurred at Broom of Moy. A positive line of enquiry is being followed in relation to this. A national campaign aimed at driving down bogus caller crime was launched on 9 September. "Beat Bogus Callers" is designed to give older and vulnerable people the confidence to keep their doors shut to uninvited callers. In many cases, this simple action can mean the





difference between falling victim to doorstep crime or not. Community Warden's Report

There have been no noise complaints or incidents of dog fouling in the area.

A dog poo quiz has been compiled for distribution to all primary schools in Forres and surrounding area. This is designed for parents interaction and will educate the children on the results of dog fouling on both individuals and the community.

Unlicensed traders have been renovating driveways etc. and then fly tipping. If DH can trace the waste back to a specific household he will issue a statutory fine.
