# Moray Council Empty Property Relief Policy

From 1 April 2023 the administration of Non-Domestic Rates empty property relief was devolved by Scottish Government to Scottish local authorities. Moray Council has put in place a local policy for the disposal of applications for exemption from the unoccupied property charge.
