- 301 **Road Hazard at East St.** Vehicles parked at the corner of South Street and East Street may be causing a safety issue. P. C. Kerr was informed and said he will mention it to colleagues that vehicles at the corner may be causing an issue of inconsiderate parking. **To remove**
- 302 **The Square Traffic Calming Off Ramps** LCC decided after discussion to continue to look for a solution to the lack of warning at the Off Ramps at the Square in Fochabers. LCC has received information on damage to number plates and the exhausts of vehicles.

Cllr. Ross has previously agreed to investigate options.
