## Police Report

For the period 28 April to 4 June 2014, only one crime was reported. This enquiry is still ongoing.

About 1530 hours on Thursday 1 May 2014, a school girl was struck with what is believed to have been a pellet fired from a BB gun by the occupant of a passing blue Volkswagen Golf motor car, after she had got off the school bus at Fraser Road, Burghead. The blue VW Golf was seen to head off towards St Aethan's Road.

Local Officers and specialist Roads Policing Unit Officers are continuing to give attention to local roads, including St Aethan's Road and the Burghead to Hopeman road.

Nightshift patrols in the Lossiemouth Community Policing Team area have been increased and residents are encouraged to immediately report any suspicious persons or vehicles, particularly in rural locations.

## **OPERATION CEDAR**

On 14 May 2014, Operation CEDAR was launched across Aberdeenshire & Moray to increase road safety in the area. There will be a focus on addressing poor driving standards by means of education and enforcement where necessary. The key message, embodied within the operation title, is to *Challenge, Educate, Detect and Reduce.*

## Dog fouling:

- No complaints in regards to dog fouling were received in this period.

## Initiatives:

#### Litter initiative:

Community Wardens have been conducting patrols supporting the litter initiative run by the *Northern Scot* and Moray Council.

## Clean Coastline Initiative:

Plans are currently being finalised for a clean coastline initiative to tackle and deter litter on the beaches between Roseisle and Lossiemouth this summer. This will include regular beach cleans, regular litter patrols and appropriate signage to encourage people to take their litter away with them, as well as warning them of the penalties if they fail to do so.

## Dog fouling:

On 13<sup>th</sup> June pupils from Burghead Primary will be spray painting dog mess to draw attention to the issue in Burghead.

Concerns were raised regarding speeding motorists in Cummingston. Tim Betts will talk to Council re 30 mph flashing signs for Cummingston as it was felt these had made a difference. Speed ramps for the road down to Cummingston park was also brought up which Tim will also discuss with the Council. Johnny will write formal letter if required.

#### Clean Up Moray Campaign

## **Cemetery/War Memorial**

Everyone was delighted with the progress at the Cemetery and wished to thank Ken Kennedy for this. A thank you to previous Community Council Member Abby Main for his work in ensuring this was taken care of was also expressed by all.

While we were lead to believe that funding had been given with regards to replacing the railing at the War Memorial and railings were being sourced, this is not the case. Disappointment was noted.
