SUBJECT: LICENSING (SCOTLAND) ACT 2005 - REVIEW OF PREMISES LICENCES HEARING FOLLOWING THE MAKING OF PREMISES LICENCE REVIEW PROPOSAL

BY: CLERK TO THE BOARD

1. <u>REASON FOR REPORT</u>

1.1 To ask the Board to review the licenses in relation to the Crooked Inn which was suspended by the Board following a hearing on 16 January 2014.

2. <u>RECOMMENDATION</u>

2.1 It is recommended that the Board consider and determine the premises licence review proposal having regard to the powers available to the Board under s.39(2) of the Licensing (Scotland) Act 2005 as set out in paragraph 3.7 below.

3. BACKGROUND

- 3.1 On the 16 January 2014 review proposals were made under powers delegated by the Board to the Clerk in respect of premises that had failed to pay the annual licence fee that fell due on the 1 October 2013. The review proposals stated the grounds for review in accordance with section 36(3) of the Act, which are (a) that one or more of the conditions to which the premises licence is subject has been breached, or (b) any other ground relevant to one or more of the licensing objectives.
- 3.2 A review proposal having been made, the Board was obliged to hold a hearing, in terms of s.38(1), to consider and determine the proposal.
- 3.3 In the present case, on 16 January 2014 (paragraph 3 of the minute refers) the Board found grounds for review were established in respect of the aforementioned premises both in terms of s.36(3) (a) and (b) of the Act.
 - 3.3.1 By the failure to pay the annual licence fees which became due on 1 October 2013, the licence holders concerned were breaching a mandatory condition of the premises licence, which condition is imposed by paragraph 10(2) of Schedule 3 of the Act.
 - 3.3.1 In addition, by the failure to pay the annual licence fees, the licence holders concerned had deprived the Board of revenue and this reduced the Board's ability to promote the licensing objectives.

- 3.4 As a result The Board considered it necessary or appropriate for the purposes of the licensing objectives to suspend the licence for a period of six months and review the position at today's meeting if the annual fee was still outstanding. The annual fee remains outstanding.
- 3.5 According to the last information available, the premises may currently be for sale at the hands of Insolvency Practitioners.
- 3.6 At the review hearing if satisfied that a ground for review is established take such of the steps set out in section 39(2) as the Board considers necessary or appropriate for the purposes of any of the licensing objectives. Section 39(2) confers on the Board the power to:
 - 3.6.1 Issue a written warning;
 - 3.6.2 Vary the licence;
 - 3.6.3 Suspend the licence for such period as the Board may determine including suspending the licence unless and until the fee is paid; or
 - 3.6.4 Revoke the licence.

Regulation of the sale of alcohol contributes to a safer community. Provision for appropriate staff and support will assist the Board in this.

SUBJECT: THE SCHEME OF DELEGATION

BY: CLERK TO THE BOARD

1. <u>Reason for Report</u>

1.1 The reason for this report is to invite the Board to approve an amended Scheme of Delegation for the Licensing (Scotland) Act 2005.

2. <u>Recommendations</u>

2.1. It is recommended that the Board approve the Scheme of Delegation as outlined in Appendix I of this report.

3. <u>Background</u>

3.1 The Scheme of Delegation was last approved on 9 August 2012 (para 3 of the minute refers).

4. <u>Proposals</u>

- 4.1 The functions proposed for delegation are all more fully set out in Appendix1.
- 4.2 The one suggested change since approval of the last scheme is highlighted for ease of reference.
- 4.3 The amendment is to provide for the Clerk or person appointed to assist the Clerk to revoke a personal licence under the mandatory provision in section 87(3) of the Licensing (Scotland) Act 2005, if the licence holder fails to comply with the provisions as regards training in section 87(1) of that Act. Revocation of personal licences in these circumstances is mandatory but in the absence of a delegated power for this purpose all such matters would have to be listed for a Board meeting.
- 4.4 The previously agreed Scheme of Delegation will be superseded by the Scheme of Delegation proposed in this report.

5. Implications

Appendix I



The Moray Licensing Board Scheme of Delegation for the Licensing (Scotland) Act 2005

Delegation of functions is provided for within paragraph 10 of Schedule 1 to the Licensing (Scotland) Act 2005 as follows:

A Licensing Board may authorise (whether generally or specifically) any member, committee, clerk or member of staff to exercise on behalf of the Board any of the Board's functions under the Act, other than the following:

(a) determining the Board's policy for the purposes of a licensing policy statement or supplementary licensing policy statement,

(b) determining, for the purposes of any such statement, whether there is overprovision of licensed premises, or licensed premises of any particular description, in any locality,

(c) determining a premises licence application,

(d) determining a premises licence variation application where the variation sought is not a minor variation,

(e) determining an application for the transfer of a premises licence where the applicant has been convicted of a relevant offence or a foreign offence,

(f) determining a personal licence application or renewal application where the applicant has been convicted of a relevant offence or a foreign offence,

(g) conducting a hearing under this Act (including the resulting steps like issuing a warning, suspending or revoking the premises licence, varying the licence, suspending, revoking or endorsing the personal licence)

(h) making a closure order,

(i) refusing an application for confirmation of a provisional premises licence.

(j) granting/refusing an occasional licence application where there is a notice of objection or representations in relation to the application, or a notice from the appropriate chief constable recommending refusal of the application.

Therefore the above functions will be undertaken by the Moray Licensing Board. All other functions may be carried out by any member of the Board, committee of the Board, clerk or member of staff. In particular the following will apply:
