1.0 BUSINESS ARISING FROM PREVIOUS MINUTE.

- 1.1 Pot Ale Plant Paddockhaugh- Local residents have some concerns which have been passed to Cllr. Ross. No road sign to Warn HGV's has yet been put in place.
- 1.2 Mosstowie Primary Schoolhouse access no further information.
- 1.3 Kellas House Wind Turbines no further information to hand.
- 1.4 Safety barrier C12E at Branchill farm no new information. Secretary to write again to roads department with our concerns and to ask where it is on the reserve list?
- 1.5 Schools meetings attended by members at Forres, Elgin and Lossiemouth and a brief report given. One member felt that the team came with pre-conceived ideas on what constitutes a good education. It was felt that they had been listening to feedbacks but the attendance was poor. They appear to have made up their minds about which schools should be amalgamated by the chart given –Mosstowie being one of them.
