## BUCKIE AND DISTRICT COMMUNITY COUNCIL.

A MEETING TOOK PLACE IN THE TOWN HOUSE, BUCKIE ON TUESDAY 16<sup>TH</sup> SEPTEMBER, 2014.

CHAIR – James Smith (Vice Chair) opened the meeting and welcomed all present. He said Trisha Greenwood was unable to attend the meeting and asked him to chair it.

POLICE REPORT – PC Fraser gave an update.

There has been 40 recorded crimes in the area covered by officers based in Buckie Police Office since last meeting. 16 are detected, 21 undetected, 19 of which are still ongoing with the likelihood that many of these should be detected, 1 person warned and 2 have been approved or No Crime.

There has been 1 theft by housebreaking in Buckie with a quantity of jewellery stolen amongst other personal items.

There have also been 3 other thefts. One of a bank card, one of tractor keys and one involving power tools. These enquiries are ongoing, 2 with positive lines of enquiry.

Drugs – This month has seen recoveries of personal amounts on cannabis, cocaine and valium with 3 persons being reported or investigated for their possession. A Drug Search Warrant was also executed in this period.

One further individual is being investigated for being concerned in the supply of controlled drugs.

Vandalism – There have been 7 reported of vandalism.

6 Road Traffic offences has been detected, these include speeding, driving without a licence or insurance and driving off road.

These have been 2 incidents related to the Scottish Referendum. The theft of signs and damage to another. Enquiries are ongoing.

James Smith reported a quad bike driven by a child of 8 years old with a younger passenger being driven around the Pot o'Linn area. Police to keep an eye on this.

PC Fraser and WPC Tripp were thanked before leaving the meeting.

Community Warden Andrew Mackie gave an update.

3 abandoned vehicles - all have been removed.

Cigarette campaign starts through Moray in October.

James Smith said he had received complaints from residents in Cathcart Street regarding litter now that the schools are back. CW to keep an eye on this.

CW Andrew Mackie was thanked before leaving the meeting.
