Matters Arising	The Dufftown and District Community Council have been negotiating hard for the recommended £5000 per MW community benefit fund money from the Dorenell Windfarm Development on the Glenfiddich and Cabrach Estate. The offer of £2000 per MW which was made via the Scottish Government was refused by the Community Council and the four Community Associations at a recent meeting at Glenlivet Hall. The Government and the industry group, Scottish Renewables, recommend £5000 per MW for all new agreements. Discussions have been taking place since 2008 but no agreement has yet been reached between Infinergy and the Communities of Dufftown and District, Cabrach, Glenrinnes, and Glenlivet-Inveravon.  Although the Dufftown and District Community Council does not	
		seek to be a beneficiary, we believe that we should ensure a fair deal for all. With the Dorenell Windfarm planned to be 177MW the difference between securing the recommended £5000 or accepting the £2000 on offer is over an extra half a million pounds per year for community projects for 25 years.	
		Infinergy have offered a package which would include repairs and renovations to a number of buildings on the Estate belonging to the London-based financier Christopher Moran. Many of the buildings have not received maintenance and have been neglected for decades. The historically listed Blackwater Lodge is on the Buildings	
		at Risk Register. It is understood that the renovated buildings would remain under the ownership of the landowner rather than be transferred into Community ownership. This was felt unfair.	
		Infinergy and the landowner were to meet on 15 September to discuss the Community Benefit Fund offer and return to the Communities for the next meeting in early November.
