Police Report	The latest report was distributed round the table and taken as read. Sgt Bruce asked for the public to be vigilant in locking sheds as there had been a spate of break ins. An email was received by the Police & LCC regarding the High School buses using Woodside Road, Fochabers. The concerns were — • Buses mounting the pavements • Congestion when buses are passing other vehicles • The safety of children who walk to school via Woodside Road Sgt Bruce has spoken to the coach company who said the routes are directed by Moray Council, the agreement being that they use West Street in the morning and Woodside Road in the afternoon. There is nothing the police can do as it is a public road.	
Guests	Two ladies were present to represent Portgordon Primary School Parents Council. They came to make a presentation regarding the strong community support against the proposed closure of Portgordon Primary which would result in the pupils being transported to Cluny Primary in Buckie. Their main concerns were- • Although the review group said the reasons for closure were educational, none of the parents could see what Cluny had to offer that the children didn't already have • Cluny is not big enough to take all of the Portgordon pupils • There is currently no Nursery Provision at Cluny • Young families would not be attracted to live in Portgordon if there was no Primary School • The school hall is also used for clubs which may be lost • The school day would be lengthened considerably for the children if they had to travel to Buckie • How would Nursery children get to Buckie as it was understood that only Primary pupils would be provided with buses. Many parents don't drive It was noted that LCC are in complete support of the group.
