## **Police Report**

For the period 2 October 2014 to 1 February 2015, only five crimes were reported to Police for the Burghead and Cummingston area. Two of these have been re-classified as 'No Crime' following a review of the circumstances. Out of the three remaining crimes, only one remains undetected. The following is an overview of crimes since the last Burghead Local Policing Report.

Overnight 10/11 January 2015, a vehicle parked on Station Road sustained damage to its front windscreen whilst unattended.

On 7 November 2014, a female was arrested and was subsequently charged with Threatening or Abusive Behaviour following an incident within a private dwelling at Cromarty View.

Two males have been reported to be Procurator Fiscal for various road traffic offences following the use of unregistered motorcycles in Burghead Woods and public roads in the town on 21 December 2014.

Anyone with any information on the crimes mentioned above and any crimes in the Lossiemouth Policing Area is asked to contact Police Scotland on 101, Crimestoppers on 0800 555 111 or call in person at the Lossiemouth Police Office.

Nightshift patrols in the Lossiemouth and Burghead areas have continued and residents are encouraged to immediately report any suspicious persons or vehicles, particularly in rural locations.

## **Community Warden Report**

#### Anti social behaviour:

 Anti social behaviour and its causes are continuing to be targeted along with Police Scotland and other partners.

# Dog fouling:

- o One anonymous complaint in regard to dog fouling was received in this period; plain clothes patrols have been undertaken in identified areas as well as poster installation and leaflet drops.
- Dog walkers are being engaged with and given a card reminding them of their responsibilities as well as how they can report incidents of dog fouling that they witness.
- We continue to urge people who witness dog fouling to report it on 07800 670 665; information provided by members of the public is invaluable when it comes to identifying and dealing with dog foulers.

# Neighbour disputes and noise complaints:

One neighbour dispute was reported in this period and subsequently resolved.

#### Initiatives:

## Speed checks:

After concerns were raised by the P6/7 class at Burghead Primary about vehicles speeding past the school, the P6/7 pupils operated speed checks in conjunction with PC Menzies from Police Scotland on the mornings of 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> of December on Grant Street. This resulted in two drivers being educated.

## Litter / dog fouling survey:

On 8<sup>th</sup> December pupils from Burghead Primary school conducted a litter survey and dog mess spray in Burghead to identify hot spot areas. This will be followed up by litter picks in the near future to further raise awareness and help keep Burghead tidy.

# **Bus Stops**

Everyone agreed it was great that there will now be a stop at Red Craig Drive. John had wondered if it would be possible to have road markings for the bus stop at the post office and or other bus stops similar to that at the school. It may prevent people parking right by the bus stops thus hindering elderly/disabled bus users from getting on and off the bus. John will look into this.
