We seek review of the planning decision because we find the requirement of rebuilding the access from TTF & Forresian firs to the A96 onerous and beyond our capabilities as a small charity. TTF completed a new access junction to the A96 on the 14th May 2010 at a cost to our charity of £15,944.75 as a planning requirement for monthly farmers markets dated 02/02/2010 ref 09/01722/APP. In addition our approved conversion of existing store shed to environmental education centre ref 10/00509/APP which also was conditional on the new junction which was approved on the 07/06/2010. There is no possibility of TTF raising over £20,000 of funding for the same developer contribution for what is virtually the same project 5 years on so imposing this developer contribution does nothing to improve road safety on the A96 Forres bypass.

The community car boot sale is proposed on a Sunday morning when traffic is light on the A96 and is only busy on good days when visibility & road safety are maximised. We use the access junction for much busier events throughout the week in all weathers & have an ever increasing number of public events as permitted by our existing planning permission. Given this we feel that any increase in waiting and turning manoeuvres on this section of trunk road due to the community car boot sale would be negligible. We are very aware of the road safety problem which is at its worst in the dark days & early nights around xmas when Forresian Firs also have a high volume of customers entering and leaving via the access to rent/buy their sustainable xmas trees.

We would comply with any required/permitted road safety improvements which are achievable. The TTF bootsale is a small but valuable community event giving free fundraising spaces to local clubs and charities and building a strong spirit of community.
