**MINUTE OF MEETING** of 3<sup>rd</sup> February 2015

## 1.0 BUSINESS ARISING FROM PREVIOUS MINUTE.

- 1.1 Mosstowie Primary Schoolhouse access The report back stated that Moray Council did not own the School house or the grounds around it and the owners said they would not sell them. If the school was to close it would revert back to the owners. Moray Council do however keep it wind and water tight.
- 1.2 Kellas House Wind turbines no further information and no consultation with community.
- 1.3 Dallas pavements have almost been repaired. Mr Stuart Dale the Enforcement Officer is investigating why the Pavements outside the new houses have not yet been completed.
- 1.4 Red Squirrels no signs yet.
- 1.5 Cllr.Cree's letter circulated to all.
- 1.6 Fire safety talk arranged for 28<sup>th</sup> April.
- 1.7 Garrowslack road flooding cleared.
- 1.8 Rashcrook road flooding cleared.
- 1.9 Bridge railings at Pluscarden Church to be repaired by July.
- 1.10The member for Fogwatt thanked the Community Council and Cllr.Ross for highlighting the concerns of the Fogwatt Community about Earth time at Millbuies. No-one is against this activity just the location. Moray Council have not yet given permission for this activity to commence.
- 1.11 Although Heldon Community Council has no objection to a Hustings it was felt that they should not organize it. It should be left to those who wish to take part not Heldon Community Council.
- 1.12 Most potholes have been repaired or are in the process of repair. The Community Council agreed that the roads department acted quickly on their requests for repairs. The Secretary told the Council that although she had given road details to the call centre dealing with this, the roads engineer had to call her twice to find out exactly where the potholes were. She felt it would have been better if she could email the details, then nothing was lost in translation. The rule is however, that all calls go through the call centre.
- 1.13 Keith Community Radio did not manage to attend the meeting.
- 1.14 The waste management talk was very informative and gave us all a refresher course in what to put where.

  Questions and answers followed and it was felt that it was a worthwhile talk. All members were given a leaflet to display on their village noticeboards.
- 1.15 Financial Support for Community Councils return completed. Cllr.Wright said the information was in the process of being collated. The purpose of the report was to ensure that money was spent wisely. He was thanked for the information.
