Elaine then set out the road changes for Cluny Square and the High St Buckie.

In essence Cluny Square will have slight road improvements, the existing railings will be removed and traffic lights installed at all junctions.

The existing zebra crossing will be moved further south and change into a Pelican crossing (pedestrian controlled)

The Junction at East and West Cathcart Street will have traffic lights.

The junction at Well road and Highfield road will have traffic lights and a pedestrian island added

Throughout the length of the High St road narrowing will take place at several points also creating bicycle safe riding areas. A public exhibition will be set up in the library area within the next 2 weeks, timings to be announced.
