**CHAIR** – The meeting was opened by Trisha Greenwood who welcomed all present including our newest member Norman Calder and Sonya Warren on her appointment to The Moray Council. Trisha invited the Police to give their report.

Police Report – Since the last meeting there have been:-

15 reports of thefts being committed, 1 of which has been detected with the rest ongoing. The majority of these relate to shoplifting, but there has been an increase in sneak –in thefts for domestic properties. Police urge all householders to ensure their property is secure at all times.

2 accounts of Drug abuse of suspected cocaine and cannabis.

6 instances of vandalism, Police urge that any additional evidence regarding these type of crimes would be appreciated.

2 drink drivers identified.

5 Assaults and Domestic Incidents have been reported, 3 of which are under investigation.

Fair Warning Initiative for Anti-social driving in Buckie. Reported so far 2 drink drivers, 3 for driving without a licence, 2 for driving without insurance, 1 for driving without an MOT and 1 for failing to stop after a RTA.

**Community Wardens report** – No Community Warden in attendance. Secretary to ask if he can attend.

**Minutes of the March meeting**. The proposal that they be adopted as a True Recording was moved by John Cowie and seconded by Ann Mitchell.
