SUBJECT: THEMATIC REVIEW – THE INCLUSION OF CHILDREN WITH

ADDITIONAL SUPPORT NEEDS

1. REASON FOR REPORT

1.1 The purpose of this report is to ask the Committee to scrutinise and note a report on a thematic review.

1.2 This report is submitted to Committee in terms of Section III D (1) of the Council's Administrative Scheme relating to exercising the functions of the Council as Education Authority.

2. **RECOMMENDATION**

3. BACKGROUND

- 3.1 At a meeting on 12 December 2012, the Children and Young People's Services Committee scrutinised and endorsed the department's plans for self-evaluation, including thematic reviews (paragraph 10 of the minute refers).
- 3.2 The Continuous Improvement Team (CIT), and departmental Peer Reviewers, undertook a thematic review into 'The Inclusion of Children with Additional Support Needs', in February 2014.

3.3 The CIT was supported, in conducting the review, by Education Scotland. An HMI national specialist in inclusion, worked alongside the CIT during the review, providing advice and evaluation of areas of service. This partnership with Education Scotland, provided valuable guidance for the CIT in identifying areas for investigation; and ensured evaluations and recommendations were consistent with the national position.

3.4 The report on the outcomes of the review, including recommendations for improvement, is contained in **Appendix 1.**
