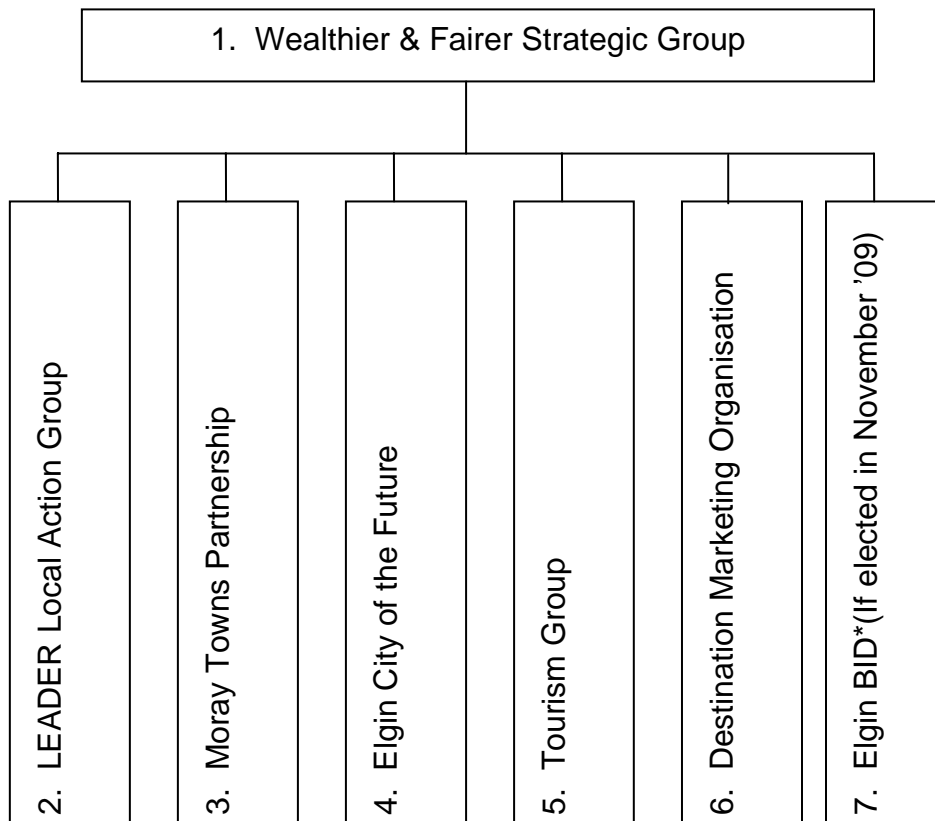

2. LEADER Local Action Group (LAG) – Remit and Membership

Remit

The Moray LAG partnership intends to operate on a collective and non representative basis which is focused on the delivery of the Moray LEADER strategy. Each partner organisation will have an equal voice in decision making; the partnership will seek to reach all decisions by consensus in so far as is practicable. Priority will be given to optimising the LAG's networking potential with other partnerships and groups through member's wider involvement. LAG partner organisations will also be encouraged to involve colleagues with relevant connections, knowledge, skills or capacity as appropriate thus adding value to the partnership and the delivery of the strategy.

The LAG's principal responsibilities will be:

- Ongoing strategy monitoring and development
- Promoting the programme locally
- Driving the community engagement and participation process
- Establishment and overview of financial and operational structures
- Monitoring physical and financial progress and strategic outcomes
- Effective liaison with the Community Planning Partnership to optimise complementarity for LEADER with other local plans and strategies
- Active liaison with the RPAC
