**SUBJECT: ADOPTION OF ROADS ON TO LIST OF ROADS**

**1. REASON FOR REPORT**

- 1.1 This report asks the Committee to approve the addition of the roads specified in the schedule in the attached **Appendix** to the statutory list of Public Roads.
- 1.2 This report is submitted to Committee in terms of the Council's Administrative Scheme relating to List of Roads.

**2. RECOMMENDATION**

- 2.1 **The Committee is asked to approve the adoption of the roads scheduled in the attached Appendix to the Statutory List of Public Roads.**

**3. BACKGROUND**

- 3.1 The Moray Council as Roads Authority is required under the Roads (Scotland) Act 1984 to adopt to the Statutory List of Public Roads sections of roads which have been constructed by developers in accordance with the Council's specification.
