Scottish Planning Policy 17 – Planning for Transport	<p>50. A framework for delivering better integration of transport and land use planning will be a key policy tool. Significant travel generating uses should be located to support more sustainable travel patterns, with specified non-car mode shares. Planning Advice Note 75 – Planning for Transport	<p>42. Travel Plans are documents that set out a package of positive and complementary measures for the overall delivery of more sustainable travel patterns for a specific development. Their ability and success in influencing travel patterns is dependent upon the commitment of the developer and occupier of a development. National Transport Strategy	<p>160. We do believe it is for the public sector to demonstrate leadership in sustainable travel plans and we will continue to work with the public sector to deliver this objective. We are already supporting regional transport partnerships to take a strategic approach to sustainable travel plans through funding Travel Plan Co-ordinators in every region with £1m being invested over the first 2 years. We are producing guidance for these co-ordinators. Through this investment and support package, we want all local authorities and major hospitals and health facilities to have operational travel plans by April 2008. We expect these travel plans to develop over time with increasingly successful results.
