APOLOGIES

Apologies for absence were intimated on behalf of Councillors J Russell, I Young, Rev C M Stewart and Rev G Swanson (Religious Representatives), and Councillors G McIntyre and A Wright Ex-Officio).

1. PUPIL REPRESENTATIVE

The Chair on behalf of the Committee welcomed Fiona Jagger of Buckie High School, to her first meeting of the Children & Young People's Services Committee in her capacity as pupil representative for session 2009/10.

2. DECLARATION OF GROUP DECISIONS

In terms of Standing Order 20, Councillor Shand confirmed that the SNP Group had discussed Item 6 on the Agenda, "Draft Policy on Paired Headteacher for Primary Schools" as a group but it should, however, be appreciated that the SNP Group Members are free to vote as they see fit. There was no whip on the decision of the SNP Members and no sanctions in place to encourage them to vote in any particular way.

There were no other declarations from group leaders or spokespersons in regard to any prior decisions taken on how Members will vote on any item on the Agenda nor any declarations of Members' Interest in respect of any Item on the Agenda.

3. WRITTEN QUESTIONS

In response to the written question submitted by Councillor Ross asking if the Education Department had received any information from the Scottish Government suggesting that the SNP Government will drop any more manifesto commitments such as their pledge to reduce class sizes in P1-3 to 18, the Director of Educational Services advised that he had not received any information.

As a supplementary question Councillor Ross asked, with regard to the SNP's manifesto and policies in respect of young people's health and well being which were to provide two years of PE and swimming for each child and more centres for sporting excellence, that as the SNP was not going to act on these policies and in light of the tough financial times ahead, how was Moray as an authority going to act on this information.

In response the Head of Educational Development Services advised that in terms of class sizes he had not received any information. He further advised that the intention of the Scottish Government was to have a maximum of 25 pupils in primary 1 by August 2010, however this would not stop the Council's commitment year on year on to reduce class sizes to 18.

4. SCHOOL ATTAINMENT 2008/09

Councillor Murdoch joined the meeting during discussion of this item.

The meeting noted the presentation on attainment levels in Moray for 2008/09 by the Head of Educational Development Services.

The Chair on behalf of the Committee thanked the Head of Educational Development Services for his excellent presentation. He also extended congratulations to pupils, teachers, non-teaching staff, parents, carers and quality improvement officers for their input in respect of the achievement being made in attainment in Moray schools for 2009 - 2010.

5. PROPOSALS FOR A 32 WEEK PERIOD IN MORAY SECONDARY SCHOOLS

There was submitted a report by the Director of Educational Services asking the Committee to note the results of the consultation on the proposals for a 32 week in secondary schools and to agree discussions with secondary headteachers on a co-ordinated school day.

Following consideration the Committee agreed to:

- (i) note the results of the consultation on the proposals for a 32 week period in secondary schools;
- (ii) officers discussing with secondary headteachers the move to a co-ordinated school day; and
- (iii) a report on the topic being brought to a future meeting of this Committee for a decision.

6. DRAFT POLICY ON PAIRED HEADTEACHERS FOR PRIMARY SCHOOLS

There was submitted a report by the Director of Educational Services inviting the Committee to consider key principles on paired headteachers and seeking agreement to consult on these principles.

In response to concerns expressed by Councillor Shand with regard to the draft policy where he advised that he had difficulty with the bullet points at paragraph 3.7 of the report referring to suitability, flexibility and costs for filling a vacancy and could not support the proposals, the Head of Educational Development Services clarified the position and advised that the report was only seeking permission to go out to consultation on the key principles which would provide flexibility when posts become vacant.

The Head of Educational Resource Services advised that under national guidelines, any headteacher who refused an interview or was unsuccessful would be demoted to a normal teaching role, but would continue to be paid a headteacher's salary for three years. With regard to the costs referred to in paragraph 4 (c) of the report he advised that these costs referred to the previous pilot and should any additional costs be incurred these would be contained within the existing overall budget.

The Director of Educational Services endorsed the comments of the Head of Educational Services and the Head of Educational Resource Services.

Thereafter, Councillor Shand, seconded by Councillor Coull, moved that recommendations (i) and (ii) of the report be deleted and replaced with a new recommendation "to retain current policy".

As an Amendment, Councillor Hamilton, seconded by Councillor Hogg moved approval of the recommendations as written.

- (iv) that the project be referred to as Moray Sports Facilities and Elgin High School Arts Provision'.
