Accompanied by reductions in: management, learning centre staff, and the purchases of books and other materials. Libraries to close: Burghead, Findochty, Portknockie, Rothes, Hopeman, Cullen, Dufftown and one mobile unit.

6. What are the potential negative impacts?

Note: page numbers refer to the report on the consultation about library closures. The biggest impact that came out of the consultation is the difficulty in accessing alternative libraries. This then leads to other impacts such as having no access to IT equipment and support with IT, educational attainment, impact on quality of life. The effect is exacerbated when, instead of removing one library in an area, a cluster of libraries is removed. Although the distance to the nearest remaining library may not seem that much, table 10 (p.21) shows that the cost of public transport become prohibitive, especially for those on low income or families with children.

Age young:

educational attainment (pp. 22-23). Age 0 - 3: research indicates the importance of early exposure to books to educational attainment later in life. Although this doesn't depend solely on libraries, they are an important link in the overall chain.

Age 3 – 5. As above. Access to story time.

Primary school age: Access to summer reading challenge. 45 responses were received from parents whose children taken part in the summer reading challenge. Access to computers for homework.

Secondary school age: tables 6 and 8 (pp. 18-19) shows a significant drop in frequency of library visits for this group.

Free access to transport is available for people with a disability and the elderly, but this doesn't help overcome issues regarding number of books people can carry and the difficulty in making transport arrangements. It also doesn't mitigate against the impact on people who are unemployed and or families with children. The dial-a-bus service in Moray is being extended and will be promoted more widely. The effect of this will need to be monitored.	1 October 2013
Encourage community groups to deliver some of the services and facilitate this through Community Asset Transfer. This could consist of book lending or exchange services. However, it must be stressed that this will not count towards establishing the statutory adequacy of the council's library provision.	Ongoing

Access to ICT with support	
There will be a need for accessible ICT with support and supervision in the communities in the absence of the libraries. This need is likely to increase as the Digital by Default programme is rolled out. Currently, there are problems with access to broadband in the areas around Dufftown and Burghead. The investment project currently undertaken by Highlands and Islands Enterprise is likely to resolve the issues in the area around Burghead by 2016 but not in the Dufftown area. It is recognised that a revised strategic network of libraries will lead to a loss of libraries in 4 communities in Moray. The mitigating actions outlined in section 8 will help minimise the impacts on the various protected groups identified in the impact assessment, particularly people with a disability, the elderly and families with children in the 0 - 3 age range. The revised network detailed in Appendix 5 is considered to represent a proportionate means of achieving the Council's legitimate aim of maximising efficiencies within the libraries service, measures having been identified to mitigate adverse impacts identified as far as is possible in the context of a strategic network which must be delivered with finite resources.
